### A BILL FOR AN ACT

RELATING TO CRIME REDUCTION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that weed and seed is a
strategy sponsored by the United States Department of Justice
and is administered locally by the United States Attorney's
Office for the District of Hawaii. Initiated in 1992, weed and
seed was developed to demonstrate an innovative and
comprehensive approach to law enforcement and community
revitalization.

8 The weed and seed strategy is a collaborative effort among 9 law enforcement agencies at the federal, state, and county 10 levels, social service agencies, private businesses, nonprofit 11 organizations, and residents to reclaim, restore, and rebuild 12 communities.

13 The four key elements of the weed and seed strategy are:

14 (1) Law enforcement;

15 (2) Community policing;

16 (3) Prevention, intervention, and treatment programs; and17 (4) Neighborhood restoration.

The weed and seed strategy works with local law enforcement to weed out violent crime, gang activity, and drug use and trafficking in targeted areas. The strategy then works to seed the revitalization of the targeted areas by restoring the neighborhood through social and economic revitalization.

6 The legislature finds that the weed and seed strategy is 7 currently being implemented in over one hundred fifty 8 communities across the country. The State has benefited greatly 9 from weed and seed programs at sites on Oahu that encompass Ala 10 Moana, Chinatown, downtown Honolulu, Kalihi, Waipahu, and Ewa 11 Beach. Since the implementation of the strategy, crime in those 12 areas has been reduced significantly. The legislature further 13 finds that the strategy's success warrants maintaining the 14 operations of the weed and seed program in these communities, 15 and expanding it to other communities in the future.

16 The purpose of this Act is to establish a permanent weed 17 and seed strategy within the department of labor and industrial 18 relations, and make an appropriation for the weed and seed 19 strategy.

17	programs to be under the auspices of and coordinated through the
18	office:
19	(1) Progressive neighborhoods program;

1 (4) State immigrant services center [-;]; and 2 (5) Weed and seed strategy." 3 SECTION 4. There is appropriated out of the general 4 revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2015-2016 and 5 6 the same sum or so much thereof as may be necessary for fiscal 7 year 2016-2017 to maintain the weed and seed strategy in areas 8 currently designated for weed and seed strategy and to expand 9 the weed and seed strategy into other areas of the State; 10 provided that any appropriation shall be conditioned on 11 obtaining federal funding for the weed and seed strategy in a 12 designated area. 13 The sums appropriated shall be expended by the department 14 of labor and industrial relations for the purposes of this Act. 15 SECTION 5. Statutory material to be repealed is bracketed and stricken. New statutory material is underscored. 16 17 SECTION 6. This Act shall take effect on July 1, 2015.
