11	(2)	Provide incentives to local entrepreneurs to cultivate

13		reforestation programs or commercial operations;

15		sustainability of commercial sandalwood operations in

- (4) Enforce penalties against persons who violate this

- 3 §183-B Destruction or harvesting of sandalwood trees. (a)
- 4 It shall be unlawful to destroy or harvest a tree of a native
- 5 sandalwood species that is determined by the department to have
- 6 been in existence prior to the year 1778.
- 7 (b) It shall be unlawful to destroy or harvest a tree of a
- 8 native sandalwood species not described in subsection (a)
- 9 without a license issued by the department.
- 10 (c) Any person who destroys or harvests a native
- 11 sandalwood species tree shall replant native sandalwood species
- 12 trees in an amount equal to the total estimated age of all trees

3	(b) All fees collected pursuant to subsection (a) shall b		
4	deposited in the treasury of the State for use by the department

7	§183-D Criminal penalties. Any person who violates		
8	section 183-B, upon conviction thereof, is guilty of a		
9	misdemeanor and shall be fined not more than \$ or		
10	imprisoned not more than one year, or both. In addition to any		
11	other penalty imposed under this section, a fine of up to		
12	\$ shall be levied for each tree illegally destroyed or		
13	harvested under section 183-B."		
14	SECTION 2. This Act does not affect rights and duties that		
15	matured, penalties that were incurred, and proceedings that were		
16	begun before its effective date.
