A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the near shore
- 2 marine resources of the State have declined over several
- 3 generations, impacting Native Hawaiian traditional and customary
- 4 practices, all residents' lifestyle, and the visitor industry.
- 5 Land-based sources of pollution, invasive species, overuse, and
- 6 poor management have all played a part in our near shore ocean's
- 7 decline. At the same time, present and future users should be
- 8 able to partake in the ocean as past generations once did. This
- 9 situation necessitates the implementation of innovative and
- 10 effective approaches, policies, and regulations that are
- 11 informed by the values of the people of Hawaii.
- 12 The legislature further finds that Hawaii's people have a
- 13 long tradition of resource stewardship and strong stewardship
- 14 values that are essential to reversing resource declines.
- 15 Community-based co-management of near shore marine areas, that
- 16 is, communities working with government, is recognized as an
- 17 effective tool to increase opportunities for stakeholder



- 1 involvement, re-invigorate Hawaii's history and culture of
- 2 mälama 'āina, increase voluntary compliance with regulations, and
- 3 ultimately improve resource conditions and availability for
- 4 future generations. In more than two dozen coastal areas across
- 5 the State, local communities want to engage in marine co-
- 6 management to sustain resources and preserve traditional
- 7 practices. All of these processes include families, fishermen,
- 8 kūpuna, youth, government, and many others with deep and caring
- 9 ties to their coastal areas.
- 10 The legislature further finds that efforts need to be
- 11 devised to bring users and other interests together rather than
- 12 further dividing them. These efforts promote tradition and
- 13 culture not as artifacts to be preserved in books and museums,
- 14 but as solutions to be practiced as keys to a sustainable
- 15 future.
- 16 Research and experience in Hawaii and around the world
- 17 demonstrate that community-based co-management of marine
- 18 resources in partnership with government can be a successful
- 19 policy and management strategy because:

1	(± /	it recognizes and nonors the unique resources,
2		habitat, condition, people, and tradition of each
3		place;
4	(2)	Community members have a high level of identification
5		with and commitment to their place;
6	(3)	Community members are respected as local leaders and
7		directly involved in decisions and management with
8		shared norms, trust, communication, and connection
9		between networks and groups of stakeholders;
10	(4)	Co-management fosters a sense of kuleana through
11		genuine sharing of responsibility and authority with
12		government in policy development, decision-making, and
13		setting standards of conduct; and
14	(5)	An engaged community has a shared commitment to
15		compliance in preservation, achievement of successful
16		resource enhancement, and promotion of sustainable
17		use.
18	The o	department of land and natural resources has the
19	statutory	mandate to implement policies and management
20	strategie	s, which include community-based co-management, to
21	preserve a	and protect Hawaii's marine resources and traditional

1 practices. In order to successfully implement appropriate 2 programs and to grow and maintain the active participation and 3 trust of communities, the department needs consistent technical 4 and staff capacity to engage with communities and other 5 stakeholders and to deliver government services effectively. 6 The legislature further finds that the increase in ocean 7 use and threats necessitates the development of innovative 8 partnerships, policies, regulations, and strategies in the 9 department of land and natural resources to ensure the 10 department meets its mandate to properly manage and administer 11 the aquatic resources of the State. In the area of community-12 based co-management of marine resources, this includes having 13 the essential staff members who can engage with interested 14 communities and help them to coordinate traditional stewardship 15 practices with the departmental systems and processes, to 16 develop community-driven rules and standards of conduct that 17 meet the State's regulatory requirements, and to implement a 18 collaborative and effective approach to compliance with 19 community-based standards and rules.

1	The purpose of this Act is to establish a community-based		
2	marine resources grant program and make key positions permanent

4	SECTION 2. Chapter 171, Hawaii Revised Statutes, is		
5	amended by adding a new section to be appropriately designated		
6	and to read as follows:		
7	"§171- Community-based marine resources grant program.		
8	(a) There is established a community-based marine resources		
9	grant program for communities engaged in near shore marine		
10	resource co-management programs with the department. The grant		
11	program shall be developed and administered by the department.		
12	Grant moneys shall be applied to support planning, stakeholder		
13	outreach, and related activities.		
14	(b) Individual grant awards under this program shall:		
15	(1) Not exceed \$10,000 per community each year;		
16	(2) Be subject to prior approval by the board of land and		
17	natural resources; and		
18	(3) Be managed by a qualified non-profit or government		
19	fiscal sponsor that charges no more than a ten per		
20	cent overhead rate for financial management.
