### A BILL FOR AN ACT

RELATING TO PASSENGERS RIDING IN BED OF PICKUP TRUCKS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 291-14, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "§291-14 Pickup trucks; passenger restrictions[-]; 4 liability. (a) No person shall stand in the bed or load-5 carrying area of any motor vehicle commonly known as a pickup truck while the vehicle is in operation. No operator of any 6 7 pickup truck shall operate the vehicle with a passenger seated 8 in the bed or load-carrying area of the vehicle unless: 9 There is no seating available in the cab of the (1) 10 vehicle; The side racks of the vehicle are securely attached 11 (2) 12 and the tailboard or tailgate is securely closed; and 13 (3) Every passenger in the bed or load-carrying area of the vehicle is seated on the floor and does not 14 15 attempt to control unlashed cargo. 16 (b) This section shall not apply to persons or

- 6 designed primarily to transport property or cargo, with sides
- 7 and a tailgate to retain the contents within the confines of the
- 8 bed, and has a maximum gross vehicle weight rating (GVWR) of

- 10 SECTION 2. This Act does not affect rights and duties that
- 11 matured, penalties that were incurred, and proceedings that were
- 12 begun before its effective date.
- 13 SECTION 3. Statutory material to be repealed is bracketed
- 14 and stricken. New statutory material is underscored.
- 15 SECTION 4. This Act shall take effect upon its approval.

Pickup Truck; Passengers; Liability

Raises the age of passengers prohibited to ride in the bed of a pickup truck under certain conditions from twelve or under to under eighteen years of age.
