A BILL FOR AN ACT

RELATING TO WILDLIFE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The interstate wildlife violator compact is a
- 2 multistate agreement that promotes enforcement of hunting,
- 3 fishing, trapping, and other wildlife related regulations across
- 4 jurisdictions. For example, the interstate wildlife violator
- 5 compact could prevent wildlife violators who have lost their
- 6 hunting, fishing, trapping, or other wildlife related privileges
- 7 in other member states from obtaining a hunting license in
- 8 Hawaii. Similarly, persons who have been punished with license
- 9 revocation in Hawaii would be unable to avoid this punishment by
- 10 engaging in those activities in another state. The compact also
- 11 establishes a process by which nonresident wildlife law
- 12 violators can be treated as state residents for purposes of law
- 13 enforcement, thereby easing the administrative burden on the
- 14 enforcement agency and reducing enforcement gaps that may allow
- 15 the violator to fail to comply with the terms of the citation.
- 16 The legislature finds that reciprocity agreements such as the
- 17 interstate wildlife violator compact are an important part of
- 18 any law enforcement effort.

- 1 The interstate wildlife violator compact is modeled after
- 2 the successful multistate driver license compact and nonresident
- 3 violator compact. Hawaii is party to both compacts. Forty-
- 4 seven states have passed legislation necessary to join the
- 5 interstate wildlife violator compact.
- 6 The legislature further finds that existing member states
- 7 to the interstate wildlife violator compact have reported little
- 8 to no added costs or administrative burdens associated with
- 9 participating in the compact. The information system that
- 10 facilitates participation is available for free to member
- 11 states.
- 12 The purpose of this Act is to allow the department of land
- 13 and natural resources to become a member of the interstate
- 14 wildlife violator compact or similar agreement.
- 15 SECTION 2. Chapter 183D, Hawaii Revised Statutes, is
- 16 amended by adding a new section to part I to be appropriately
- 17 designated and to read as follows:
- 18 "\$183D- Interstate wildlife violator compact. (a) The
- 19 department may enter into the interstate wildlife violator
- 20 compact or similar agreement, whether in the form of a
- 21 memorandum of understanding, written agreement, or mutual aid

- 1 compact, with an appropriate state, federal, or foreign entity
- 2 for mutual assistance in the enforcement of hunting, fishing,
- 3 and other wildlife laws, rules, or regulations in their
- 4 respective jurisdictions.
- 5 (b) Employees of the department who perform an act of
- 6 omission or commission in administering or enforcing the terms
- 7 or conditions of the agreement entered into pursuant to
- 8 subsection (a), if the act is within the course and scope of
- 9 their employment in administering or enforcing the agreement,
- 10 shall be:
- 11 (1) Immune from civil liability for damages;
- 12 (2) Entitled to legal representation for defense of legal
- actions in which they are a named party or of claims
- in which they are implicated; and
- 15 (3) Entitled to indemnification for any damages arising
- from legal actions or claims resulting therefrom.
- 17 (c) The department may adopt rules pursuant to chapter 91
- 18 necessary for enforcement of the agreement entered into pursuant
- 19 to subsection (a)."
- 20 SECTION 3. There is appropriated out of the general
- 21 revenues of the State of Hawaii the sum of \$ or so much

- 1 thereof as may be necessary for fiscal year 2016-2017 for the
- 2 department of land and natural resources to enter into the
- 3 interstate wildlife violator compact.
- 4 The sum appropriated shall be expended by the department of
- 5 land and natural resources for the purposes of this Act.
- 6 SECTION 4. New statutory material is underscored.
- 7 SECTION 5. This Act shall take effect on July 1, 2050.
