# A BILL FOR AN ACT

RELATING TO HAWAIIAN LANGUAGE.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1        MĀHELE 1. Ua noi'i a 'ike ka 'aha'ōlelo e pono e paipai a e  
2        ho'oholo mua 'ia ka ho'ohana me ka hō'i'o 'ia o ka 'ōlelo Hawai'i ma  
3        muli o ka 'atikala X māhele 4 o ke kumukānāwai o ka Moku'āina 'o  
4        Hawai'i nāna i ho'ākāka "na ka Moku'āina nō e ho'opaipai i ke a'o i  
5        ka 'ike mo'omeheu, mō'aukala a me ka 'Ōlelo Hawai'i." A laila  
6        ho'i, ho'opia ka 'atikala XV, māhelē 4 o ke kumukānāwai o ka  
7        Moku'āina 'o Hawai'i "'o ka 'Ōlelo Haole a me ka Hawai'i nā 'ōlelo  
8        kūhelu o Hawai'i."

9        Ma ka makahiki 2015, ua 'āpono ka 'aha'ōlelo i ka H.C.R. Helu  
10      217 H. D. 1, S. D. 1, e noi ana i ka 'oihana ho'okolokolo e  
11      ho'onoho i kōmike noi'i no ka noi'i 'ana i ka ho'okumu 'ana i mau  
12      kumuwaiwai 'ōlelo Hawai'i no ko ka Moku'āina 'oihana ho'okolokolo.  
13      Ho'opa'a 'ia ma ka hō'ike a ia kōmike noi'i, "Mau nō ke kūlana 'ane  
14      halapohe o ka 'ōlelo Hawai'i i loko na'e o kekahi mau kekeke  
15      ho'oikaika ho'ōla kūpa'a me ka māhuahua 'ana mai o kekahi heluna  
16      kānaka ho'opuka 'ōlelo". Ho'omaopopo a 'ike ka 'aha'ōlelo ē 'o nā  
17      mana'o i hāpai 'ia e ke kōmike noi'i ma kona hō'ike 'o ia ka mea e



1 kōkua ai i ka ho‘okumu ‘ana i mau kūmole hikialoa a i papahana e  
2 ho‘okawowo ai i mau kānaka mākaukāu ma ka ‘ōlelo Hawai‘i.

3 ‘O ka ho‘opa‘a ‘ana i ha‘awina kālā ke kumu o kēia Kānāwai no  
4 ka ‘oihana ho‘okolokolo nāna e ho‘okō i nā mana‘o i hāpai ‘ia e ke  
5 kōmike noi‘i no ka ho‘okumu ‘ana, me ka hana like ‘ana me ka  
6 ‘ōnaehana o ke Kulanui o Hawai‘i i nā kumuawaiwai no ka ‘oihana  
7 ho‘okolokolo o ka Moku‘āina ‘o Hawai‘i.

8 MĀHELE 2. E ho‘oka‘awale ‘ia mai loko mai o ka waihona kālā  
9 kūmau o ka Moku‘āina ‘o Hawai‘i ka huinanui he \$500,000 a ‘o ia  
10 ‘ano heluna e like me ka lawa e pono ai no ka makahiki kālā 2016  
11 - 2017 no ka ‘oihana ho‘okolokolo, me ka hana like pū ‘ana me ka  
12 ‘ōnaehana o ke Kulanui o Hawai‘i no ka ho‘okumu ‘ana i mau  
13 kumuawaiwai ‘ōlelo Hawai‘i no ko ka Moku‘āina ‘o Hawai‘i ‘oihana  
14 ho‘okolokolo.

15 Na ka ‘oihana ho‘okolokolo e ho‘oka‘a i ka huinanui i  
16 ho‘oka‘awale ‘ia no nā pahuhopu o kēia kānāwai.

17 SECTION 3. The legislature finds that the State must  
18 encourage and advance the use and utility of the Hawaiian  
19 language because article X, section 4, of the Hawaii State  
20 Constitution provides that "[t]he State shall promote the study



1 of Hawaiian culture, history and language". In addition,  
2 article XV, section 4, of the Hawaii State Constitution affirms  
3 that "English and Hawaiian shall be the official languages of  
4 Hawaii".

5 In 2015, the legislature adopted H.C.R. No. 217, H.D. 1,  
6 S.D. 1, requesting the judiciary to convene a task force to  
7 examine establishing Hawaiian language resources for the State  
8 of Hawaii judiciary. The task force's report states that the  
9 Hawaiian language "remains highly endangered even after decades  
10 of dedicated revitalization efforts and an ever-growing  
11 population of speakers". The legislature finds that the  
12 recommendations made by the task force in its report can help to  
13 establish long-term Hawaiian language resources and capacity  
14 building to train experts in the Hawaiian language.

15 The purpose of this Act is to make an appropriation to the  
16 judiciary to implement the recommendations of the task force to  
17 establish, in collaboration with the University of Hawaii  
18 system, Hawaiian language resources for the State of Hawaii  
19 judiciary.

20 SECTION 4. There is appropriated out of the general  
21 revenues of the State of Hawaii the sum of \$500,000 or so much



1 thereof as may be necessary for fiscal year 2016-2017 for the  
2 judiciary, in collaboration with the University of Hawaii  
3 system, to establish Hawaiian language resources for the State  
4 of Hawaii judiciary.

5 The sum appropriated shall be expended by the judiciary for  
6 the purposes of this Act.

7 SECTION 5. This Act shall take effect on July 1, 2016.
