BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 10 (1) No less than eighty-eight per cent of the revenue from
- 11 the nursing facility sustainability fee shall be used

- increasing medicaid payments to private nursing

There is appropriated out of the nursing 6 facility sustainability program special fund the sum of 7 8 \$14,000,000 or so much thereof as may be necessary for fiscal year 2016-2017 for uses consistent with the nursing facility 9 sustainability program special fund. 10 11 The sum appropriated shall be expended by the department of human services for the purposes of this Act. 12 13 SECTION 5. Statutory material to be repealed is bracketed 14 and stricken. New statutory material is underscored. SECTION 6. This Act shall take effect on July 1, 2016; 15 provided that sections 1 and 2 shall take effect on June 29, 16 17 2016.
