#### A BILL FOR AN ACT

RELATING TO IDENTIFICATION CARDS FOR PERSONS WITH DISABILITIES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This legislature finds that some persons with
- 2 disabilities have the desire to indicate their disability on
- 3 their state identification card or driver's license. An
- 4 identification card clearly indicating a person's disability
- 5 would allow the person access to certain eligible public
- 6 services such as special transportation and seating for persons
- 7 with disabilities at public events. This would also allow the
- 8 person with a disability to communicate any special needs to
- 9 police and other public safety personnel in the event of an
- 10 emergency.
- 11 The purpose of this Act is to allow persons with
- 12 disabilities to include the international handicap symbol and
- 13 information about their disability on their driver's license or
- 14 civil identification card.
- 15 SECTION 2. Chapter 286, Hawaii Revised Statutes, is
- 16 amended as follows:



- 1 1. By adding a new section to part VI to be appropriately
- 2 designated and to read as follows:
- 3 "§286-A Driver's license for persons with disabilities."
- 4 Persons with disabilities may opt to identify their disability
- 5 on their driver's license upon receipt of the required
- 6 documentation as stated in this part, from the person requesting
- 7 its inclusion. The driver's license shall display the
- 8 international handicap symbol on a location designated by the
- 9 department."
- 10 2. By adding a new section to part XVI to be
- 11 appropriately designated and to read as follows:
- 12 "§286-B Identification card for persons with disabilities.
- 13 (a) The department shall issue identification cards pursuant to
- 14 section 286-305 to persons with disabilities who meet the
- 15 requirements of this part.
- 16 (b) The identification card for persons with disabilities
- 17 shall include characteristics and content pursuant to section
- 18 286-305 and display the international handicap symbol on a
- 19 location designated by the department. On the reverse side of
- 20 the identification card shall be a space within which the

- 1 department shall enter the disability information the applicant
- 2 may request.
- 3 (c) The department may display the international handicap
- 4 symbol on the front and may print the disability information on
- 5 the reverse on any driver's license or identification card
- 6 issued pursuant to this chapter upon receipt of the required
- 7 documentation from the person requesting its inclusion.
- 8 (d) An identification card for persons with disabilities
- 9 shall be issued to a person with a temporary disability upon
- 10 presentation of a sworn affidavit of at least one medical doctor
- 11 attesting to that disability and estimating the duration of the
- 12 disability. The identification card issued to a person with a
- 13 temporary disability shall be issued for a period of six months,
- 14 and a current affidavit of a medical doctor attesting to the
- 15 continuance of the disability shall be presented at each request
- 16 thereafter."
- 17 SECTION 3. Section 286-2, Hawaii Revised Statutes, is
- 18 amended by adding two new definitions to be appropriately
- 19 inserted and to read as follows:
- 20 ""Disability" means any physical, mental, or neurological
- 21 impairment that severely restricts a person's mobility, manual



- 1 dexterity, or ability to climb stairs; substantial loss of sight
- 2 or hearing; loss of one or more limbs or use thereof; or
- 3 significantly diminished reasoning capacity.
- 4 "Person with disabilities" means any person with a
- 5 permanent or temporary disability."
- 6 SECTION 4. Section 286-305, Hawaii Revised Statutes, is
- 7 amended to read as follows:
- 8 "§286-305 Contents and characteristics; form. (a) Each
- 9 identification card issued by the examiner of drivers shall
- 10 display a distinguishing number assigned to the cardholder, and
- 11 shall display the following inscription:
- 12 "STATE OF HAWAII IDENTIFICATION CARD"
- 13 (b) The examiner of drivers, after obtaining the
- 14 fingerprint of the applicant as provided in this part and after
- 15 obtaining the information required by or pursuant to this part,
- 16 shall issue to each applicant an identification card in a form
- 17 and with identifying information that the director deems
- 18 necessary and appropriate, including a notation of veteran
- 19 status, if desired by the applicant, on the front of the card
- 20 where applicable; provided that [such] the notation shall not
- 21 include any designation other than the term "veteran". As used



- 1 in this subsection, "veteran" means any person who served in any
- 2 of the uniformed services of the United States and was
- 3 discharged under conditions other than dishonorable.
- 4 (c) The identification card shall not display the
- 5 cardholder's social security number.
- 6 (d) The identification card shall be designed to prevent
- 7 its reproduction or alteration without ready detection.
- 8 (e) The identification card for individuals under twenty-
- 9 one years of age shall have characteristics prescribed by the
- 10 examiner distinguishing it from that issued to [a] an individual
- 11 who is twenty-one years of age or older.
- 12 (f) A person with disabilities may request the inclusion
- of information about the person's disability on the person's
- 14 identification card, pursuant to section 286-B. The
- 15 identification card shall include the information about the
- 16 disability on the back of the identification card and display
- 17 the international handicap symbol on a location designated by
- 18 the department."
- 19 SECTION 5. In codifying the new sections added by section
- 20 2 and referenced in section 4 of this Act, the revisor of



- 1 statutes shall substitute appropriate section numbers for the
- 2 letters used in designating the new sections in this Act.
- 3 SECTION 6. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 7. This Act shall take effect on July 1, 2016.
