A BILL FOR AN ACT

RELATING TO HAWAII GOOD AGRICULTURAL PRACTICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii's farms and
- 2 farmers reflect the heritage and diversity of many cultures and
- 3 are the cornerstones of the State's goals for food security,
- 4 sustainability, and self-sufficiency. The number of small farms
- 5 in Hawaii has grown substantially during the last ten years,
- 6 reflecting a shift in the agricultural landscape from
- 7 plantations to smaller farms with diverse cropping and marketing
- 8 systems that create new local food sources and increase
- 9 employment. This trend necessitates the development and
- 10 implementation of risk-reducing guidelines and a science-based
- 11 Hawaii good agricultural practices program to decrease the
- 12 potential for food product contamination on farms.
- The legislature further finds that a Hawaii good
- 14 agricultural practices program would cover all crops and farms
- 15 and integrate risk-reducing practices, similar to the good
- 16 agricultural practices of Georgia, Canada, Kenya, Thailand, and
- 17 the United States Department of Agriculture Agricultural



- 1 Marketing Service's harmonized audit, and support farm practices
- 2 in a variety of areas. These areas include field management;
- 3 proper hygiene; water quality for irrigation and produce rinse;
- 4 agricultural chemicals; use of animal manure; pest and on-farm
- 5 animal management; pesticide, fertilizer, and soil amendment
- 6 use; packing-shed operations and maintenance; and product
- 7 trackback.
- 8 The legislature additionally finds that the Food Safety
- 9 Modernization Act of 2011 authorizes the Food and Drug
- 10 Administration to develop science- and risk-based criteria for
- 11 preventing food-borne illnesses and encourages states to
- 12 establish similar criteria for the safe production,
- 13 distribution, and consumer handling of food. However, due to
- 14 economic thresholds in the legislation and other factors,
- 15 relatively few farms in Hawaii will be under the authority of
- 16 the Food Safety Modernization Act and the earliest any oversight
- 17 will appear, beginning with a dozen of Hawaii's largest farms,
- 18 will be the middle of 2017. Thereafter, other farms will come
- 19 into compliance. The national focus, however, will be on bigger
- 20 agricultural states such as California, Oregon, and Michigan.
- 21 Even when the Food Safety Modernization Act produce rule takes

- 1 effect, the rule will not cover the range of important actions
- 2 that are covered under a good agricultural practices program.
- 3 The legislature also finds that the Hawaii State
- 4 Constitution mandates the preservation and protection of
- 5 agricultural resources. To fulfill this mandate with safe food
- 6 in mind, it is important that the State establish a permanent
- 7 good agricultural practices program within the department of
- 8 agriculture. Currently, the department has auditors trained in
- 9 good agricultural practices. Besides auditing farms at their
- 10 request for compliance with good agricultural practices, the
- 11 department of agriculture also performs egg, seed, and coffee
- 12 inspections. The department of agriculture has a successful
- 13 history of agricultural oversight, which is in its operational
- 14 mandate.
- The purpose of this Act is to develop and support good
- 16 agricultural practices by establishing a permanent Hawaii good
- 17 agricultural practices program for farms growing local
- 18 agricultural food products.
- 19 SECTION 2. Chapter 147, Hawaii Revised Statutes, is
- 20 amended by adding a new section to be appropriately designated
- 21 and to read as follows:

2	There is	established the Hawaii good agricultural practices
3	program t	o be administered by the department of agriculture.
4	The purpo	se of the program is to develop and support good

7	(b)	Notwithstanding any provision of law to the contrary,
8	the Hawai	i good agricultural practices program shall:
9	(1)	Develop science- and risk-based good agricultural
10		practices that reasonably reduce the potential for
11		on-farm food-borne illness and include, as
12		appropriate, specific considerations and methodologies
13		for farm sizes, practices, techniques, materials, and
14		crops;
15	(2)	Develop and implement programs to educate and train
16		Hawaii farmers to learn and implement good
17		agricultural practices in a cost-effective and
18		efficient manner;
19	(3)	Provide procedures for the voluntary verification of
20		on-farm implementation of good agricultural practices

1		and the subsequent issuance of state compliance	
2		certification; and	
3	(4)	Develop a consumer information program for publica	tion
4		and broadcast to teach home practices for the	
5		treatment and handling of fresh and processed	
6		agricultural food products.	
7	<u>(c)</u>	The department shall consult as necessary with the	<u>!</u> -
8	departmen	t of health, the University of Hawaii college of	
9	tropical	agriculture and human resources, and other state an	<u>id</u>
10	<u>federal</u> a	gencies to develop and implement the Hawaii good	
11	agricultu	ral practices program.	
12	<u>(d)</u>	The department may adopt rules under chapter 91 to) -
13	facilitat	te the implementation of this section."	
14	SECT	TION 3. There is appropriated out of the general	
15	revenues	of the State of Hawaii the sum of \$ or so)
16	much ther	eof as may be necessary for fiscal year 2015-2016 a	ınd
17	the same	sum or so much thereof as may be necessary for fisc	al
18	year 2016	5-2017 for the implementation of the Hawaii good	
19	agricultu	ral practices program.	
20	The	sums appropriated shall be expended by the department	ent
21	of agricu	alture for the purposes of this Act.
