A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The Children's Advocacy Centers of Illinois,
- 2 Illinois Coalition Against Sexual Assault, and Prevent Child
- 3 Abuse Illinois collaborated to create "Erin's Law". Erin Merryn
- 4 was raped and molested for six and a half years by a neighbor
- 5 and a family member. Erin began a crusade during her senior
- 6 year of high school in 2004 to end the silence and shame around
- 7 sexual abuse. Erin's Law has been passed in twenty-six states
- 8 and has been introduced in the legislative bodies of an
- 9 additional seventeen states. Erin's mission is to shatter the
- 10 silence and stigma around sexual abuse and to educate children
- 11 and empower them to recognize and to report abuse.
- 12 The legislature finds that schools fail to give young
- 13 students awareness of sexual abuse issues and a voice to report
- 14 if someone is violating them. Unfortunately, without such
- 15 education most children who experience sexual abuse will be
- 16 repeatedly abused for years because often the only message they
- 17 get comes from the abuser who is threatening them into silence.

- The task force shall submit a report of its findings 4 (h) and recommendations, including any proposed legislation, to the 5 legislature no later than twenty days prior to the convening of 6 the regular session of 2017. The task force shall also submit 7 its report directly to the chairs of the senate committee with 8 primary jurisdiction over education, house of representatives 9 committee with primary jurisdiction over education, senate 10 committee with primary jurisdiction over human services, and 11 house of representatives committee with primary jurisdiction 12 over human services. 13
- The department of education shall implement the 14 (i) recommendations of the task force in the 2017-2018 school year; 15 provided that if the department of education determines that 16 implementation is not possible in the 2017-2018 school year, the 17 department of education shall immediately notify the chairs of 18 the senate committee with primary jurisdiction over education, 19 house of representatives committee with primary jurisdiction 20 over education, senate committee with primary jurisdiction over 21

- 4 SECTION 3. There is appropriated out of the general
- 5 revenues of the State of Hawaii the sum of \$ or so much

- 8 The sum appropriated shall be expended by the legislature
- 9 for the purposes of this Act.
- 10 SECTION 4. This Act shall take effect on January 7, 2059.
