A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The Children's Advocacy Centers of Illinois,
- 2 Illinois Coalition Against Sexual Assault, and Prevent Child
- 3 Abuse Illinois collaborated to create "Erin's Law". Erin Merryn
- 4 was raped and molested for six and a half years by a neighbor
- 5 and a family member. Erin began a crusade during her senior
- 6 year of high school in 2004 to end the silence and shame around
- 7 sexual abuse. Erin's Law has been passed in twenty-six states
- 8 and has been introduced in the legislative bodies of an
- 9 additional seventeen states. Erin's mission is to shatter the
- 10 silence and stigma around sexual abuse and to educate children
- 11 and empower them to recognize and to report abuse.
- 12 The legislature finds that schools fail to give young
- 13 students awareness of sexual abuse issues and a voice to report
- 14 if someone is violating them. Unfortunately, without such
- 15 education, most children who experience sexual abuse will be
- 16 repeatedly abused for years because often the only message they

- 1 receive comes from the abuser who is threatening them into
- 2 silence.
- 3 The purpose of this Act is to form a task force to guide
- 4 the establishment of a program to educate public school students
- 5 on sexual abuse prevention through use of age-appropriate
- 6 curricula; provide relevant training to school teachers and
- 7 staff; and inform parents about important child sexual abuse
- 8 topics.
- 9 SECTION 2. (a) There is established the Erin's Law task
- 10 force to be convened by the legislature to review current
- 11 policies, programs, and curricula for educating students in the
- 12 public school system about sexual abuse prevention, and to make
- 13 a report of recommendations for the establishment of a program
- 14 to educate all children in grades pre-kindergarten through-
- 15 twelve in public schools on sexual abuse prevention through age
- 16 appropriate curricula.
- 17 (b) The task force shall comprise:
- 18 (1) The superintendent of education, who shall serve as
- the chair of the task force, or the superintendent's

- 21 (2) The director of health, or the director's designee;

- 3 (c) The department of education may expand the task force
- 4 to include members of community organizations involved in
- 5 providing direct services addressing sexual abuse in elementary,
- 6 middle, intermediate, and high school aged children and youth in
- 7 Hawaii.
- 8 (d) Members of the task force shall serve without
- 9 compensation. No member shall be made subject to chapter 84,
- 10 Hawaii Revised Statutes, solely because of that member's
- 11 participation as a member of the task force.
- 12 (e) An initial meeting of the task force shall be held no
- 13 later than August 12, 2016.
- (f) The task force shall review current policies,
- 15 programs, and curricula, and make recommendations for the
- 16 establishment of a program that:
- 17 (1) Educates children in grades pre-kindergarten through
- 18 twelve in public schools on sexual abuse prevention
- through age-appropriate curriculum through role plays,
- 20 discussions, activities, and books;

2		if anyone has ever touched them inappropriately,

20		and staff, and parents and guardians;

1	(4)	Requ	ired elements for an instructional program for			
2		stud	students in grades pre-kindergarten through twelve,

4		(A)	Techniques to teach children to recognize sexual			
5			abuse, equip them with skills to reduce their			
6			vulnerability, and encourage them to report the			
7			abuse;			
8		(B)	At least four sessions of instruction to			
9			reinforce the concepts learned in the program;			
10		(C)	Sessions conducted annually, building on skills			
11			and knowledge learned in previous years;			
12		(D)	Developmentally appropriate instruction for each			
13			grade level;			
14		(E)	Involvement of students as active learning			
15			participants through methods such as discussion,			
16			modeling, and role playing;			
17		(F)	Capacity to be delivered by a range of personnel			
18			and professionals, including but not limited to			
19			teachers, school counselors, and outside agency			
20			prevention educators; provided that the personnel			
21			and professionals should have a thorough

1		knowledge of child sexual abuse, including how to
2		respond appropriately to sexual abuse
3		disclosures;
4	(G)	An evaluation component with measurable outcomes;
5	(H)	Instruction that is culturally sensitive and
6		adaptable for use within varying school contexts,
7		including age, race, and special needs;
8	(I)	The use of evidence-based, age-appropriate
9		curricula that uses discussions, role plays,
10		activities, books, or other appropriate
11		educational materials and methods;
12	(L)	A professional training component for
13		administrators, teachers, and other school
14		personnel on talking to students about child
15		sexual abuse prevention, effects of child sexual
16		abuse on children, handling of sexual abuse
17		disclosures, and mandated reporting; and
18	(K)	A component that encourages parent or guardian
19		involvement within the child sexual abuse
20		program, which should inform parents or guardians
21		about child sexual abuse topics, including

-		discussion of child sexual abuse mychs,
2		characteristics of offenders, grooming behaviors,
3		and how to discuss this topic with children;
4	(5)	Title IX and any other federal and state laws and
5		policies concerning public school systems' handling of
6		sexual violence issues, to the extent that they relate
7		to sexual abuse prevention education;
8	(6)	Resources needed to implement a system-wide program
9		for child sexual abuse prevention education; and
10	(7)	Updates to laws or policies that would assist in the
11		implementation of a statewide program for child sexual
12		abuse prevention education.
13	(h)	The task force shall submit a report of its findings
14	and recom	mendations, including any proposed legislation, to the
15	legislatu	re no later than twenty days prior to the convening of
16	the regul	ar session of 2017. The task force shall also submit
17	its repor	t directly to the chairs of the senate committee with
18	primary j	urisdiction over education, house of representatives
19	committee	with primary jurisdiction over education, senate
20	committee	with primary jurisdiction over human services, and

- 1 house of representatives committee with primary jurisdiction
- 2 over human services.
- 3 (i) The department of education shall implement the
- 4 recommendations of the task force in the 2017-2018 school year;
- 5 provided that if the department of education determines that
- 6 implementation is not possible in the 2017-2018 school year, the
- 7 department of education shall immediately notify the chairs of
- 8 the senate committee with primary jurisdiction over education,
- 9 house of representatives committee with primary jurisdiction
- 10 over education, senate committee with primary jurisdiction over
- 11 human services, and house of representatives committee with
- 12 primary jurisdiction over human services.
- (j) The task force shall cease to exist on June 30, 2018.
- 14 SECTION 3. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ or so much
- 16 thereof as may be necessary for fiscal year 2016-2017 for the
- 17 operation of the Erin's Law task force.
- 18 The sum appropriated shall be expended by the legislature
- 19 for the purposes of this Act.
- 20 SECTION 4. This Act shall take effect on January 7, 2059.
