A BILL FOR AN ACT

RELATING TO CHILD AND MATERNAL DEATH REVIEWS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that comprehensive
- 2 multidisciplinary reviews of child deaths, as performed in the
- 3 past by the Hawaii child death review system that was
- 4 established by Act 369, Session Laws of Hawaii 1997, are needed
- 5 to understand risk factors for and prevent future child deaths
- 6 and keep children in the State of Hawaii safe and healthy, by
- 7 producing in-depth, accurate, and timely administration of child
- 8 health and protection programs and appropriate data reporting to
- 9 federal and state agencies.
- 10 However, the legislature finds that the system has been
- 11 inactive since 2011 and consequently, these important child
- 12 death reviews are not currently being conducted in the State of
- 13 Hawaii. The legislature notes that the child death review
- 14 system is codified under chapter 321, part XXVII, Hawaii Revised
- 15 Statutes, and is not mandatory.
- 16 Similarly, comprehensive multidisciplinary reviews of
- 17 maternal deaths are needed to understand risk factors for and



- 1 prevent the deaths of mothers during pregnancy, labor, and the
- 2 year following the birth of a child, and to inform policy making
- 3 and the establishment and administration of relevant programs.
- 4 However, the legislature finds that Hawaii does not currently
- 5 conduct such reviews of maternal deaths.
- 6 The legislature additionally finds that comprehensive
- 7 reviews of child and maternal deaths are a matter of ongoing
- 8 concern. Because the program of reviews must be sustainable,
- 9 the legislature recognizes the need to provide funding to
- 10 conduct child and maternal death reviews not only in the current
- 11 biennium, but in subsequent biennia as well.
- 12 The purpose of this Act is to ensure that the legislature
- 13 receives appropriate information about child and maternal death
- 14 reviews and to provide funding to the department of health to
- 15 conduct child death reviews and to implement a program for the
- 16 performance of maternal death reviews.
- 17 SECTION 2. Chapter 321, Hawaii Revised Statutes, is
- 18 amended by adding a new section to part XXVII to be
- 19 appropriately designated and to read as follows:
- 20 "\$321- Child death review; reports. (a) The director
- 21 shall submit an annual written report to the legislature no

- 1 later than twenty days prior to the convening of each regular
- 2 session on the status of child death reviews conducted by the
- 3 department pursuant to section 321-341. The annual report shall
- 4 include information about the department's child death review
- 5 activities, if any, in the twelve month period prior to
- 6 submission of the annual report; the total number of child
- 7 deaths in Hawaii and the causes of those deaths; and the number
- 8 of deaths of children in state custody and the causes of those
- 9 deaths, during the calendar year prior to the year of submission
- 10 of the annual report. The annual report may also include
- 11 discussion of identifiable trends in child deaths and
- 12 recommendations for system changes, including any proposed
- 13 legislation.
- 14 (b) The director shall submit a copy of any other child
- 15 death review report published by the department, including
- 16 findings and recommendations resulting from such a review, to
- 17 the legislature upon the report's publication."
- 18 SECTION 3. Chapter 324, Hawaii Revised Statutes, is
- 19 amended by adding a new section to part I to be appropriately
- 20 designated and to read as follows:

1	§324- Maternal death review; reports. (a) The director
2	of health shall submit an annual written report to the
3	legislature no later than twenty days prior to the convening of
4	each regular session on the status of reviews of maternal deaths
5	conducted by the department. The annual report shall include
6	information about the department's maternal death review
7	activities, if any, in the twelve month period prior to
8	submission of the annual report, the total number of deaths of
9	women while pregnant or within one year after a pregnancy in
10	Hawaii, the causes of those deaths, and whether the causes of
11	death were pregnancy related. The annual report may also
12	include discussion of identifiable trends in maternal deaths and
13	recommendations for system changes, including any proposed
14	legislation.
15	(b) The director of health shall submit a copy of any
16	other maternal death review report published by the department
17	of health, detailing findings and recommendations resulting from
18	such a review, to the legislature upon the report's
19	publication."
20	SECTION 4. There is appropriated out of the general
21	revenues of the State of Hawaii the sum of \$150,000 or so much

- thereof as may be necessary for fiscal year 2016-2017 for the 1
- department of health to conduct child death reviews in 2
- 3 accordance with chapter 321, part XXVII, Hawaii Revised
- Statutes, and to implement a program for the performance of 4
- maternal death reviews. 5
- The sum appropriated shall be expended by the department of 6
- 7 health for the purposes of this Act.
- SECTION 5. New statutory material is underscored. 8
- SECTION 6. This Act shall take effect on July 1, 2016. 9
