A BILL FOR AN ACT

RELATING TO INSURANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 431, Hawaii Revised Statutes, is
- 2 amended by adding a new section to article 10A to be
- 3 appropriately designated and to read as follows:
- 4 "§431:10A- Lifestyle and nutrition programs; coverage.
- 5 (a) Each individual and group accident and health or sickness
- 6 insurance policy, contract, plan, or agreement issued or renewed
- 7 in this State after December 31, 2016, shall provide to the
- 8 policyholder and individuals under twenty-six years of age
- 9 covered under the policy, contract, plan, or agreement, coverage
- 10 for lifestyle and nutrition programs intended to treat various
- 11 health conditions, including but not limited to cardiovascular
- 12 disease, diabetes, blood pressure issues, and diabetes-related
- 13 blood sugar issues.
- (b) Every insurer shall provide written notice to its
- 15 policyholders regarding the coverage required by this section.
- 16 The notice shall be in writing and prominently positioned in any
- 17 literature or correspondence sent to policyholders and shall be



- 1 transmitted to policyholders within calendar year 2017 when
- 2 annual information is made available to policyholders or in any
- 3 other mailing to policyholders, but in no case later than
- 4 December 31, 2017.
- 5 (c) Coverage under this section may be subject to
- 6 copayment, deductible, and coinsurance provisions of an accident
- 7 and health or sickness insurance policy, contract, plan, or
- 8 agreement that are no less favorable than the copayment,
- 9 deductible, and coinsurance provisions for other medical
- 10 services covered by the policy, contract, plan, or agreement.
- (d) This section shall not be construed as limiting
- 12 benefits that are otherwise available to an individual under an
- 13 accident and health or sickness insurance policy, contract,

- 21 (a) Each individual and group hospital or medical service plan

- 2 2016, shall provide to the member and individuals under twenty-
- 3 six years of age covered under the plan contract coverage for
- 4 lifestyle and nutrition programs intended to treat various
- 5 health conditions, including but not limited to cardiovascular
- 6 disease, diabetes, blood pressure issues, and diabetes-related
- 7 blood sugar issues.
- 8 (b) Every mutual benefit society shall provide written
- 9 notice to its members regarding the coverage required by this
- 10 section. The notice shall be in writing and prominently
- 11 positioned in any literature or correspondence sent to members
- 12 and shall be transmitted to members within calendar year 2017
- 13 when annual information is made available to members or in any
- 14 other mailing to members, but in no case later than December 31,
