A BILL FOR AN ACT

RELATING TO THE OFFICE OF LANGUAGE ACCESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature recognizes and acknowledges
- 2 that language can be a barrier for limited English proficient
- 3 persons in accessing important benefits or services,
- 4 understanding and exercising important rights, complying with
- 5 applicable responsibilities, or understanding other information
- 6 provided by state-funded programs and activities. Act 290,
- 7 Session Laws of Hawaii 2006, as amended by Act 201, Session Laws
- 8 of Hawaii 2012, sought to ensure that limited English proficient
- 9 persons have meaningful access to state-provided and state-
- 10 funded services in Hawaii.
- 11 The office of language access provides oversight, central
- 12 coordination, and technical assistance to twenty-six state
- 13 agencies and approximately one hundred fifty state-funded
- 14 agencies in implementing the requirements of Hawaii's language
- 15 access law.
- 16 The technical assistance provided to agencies by the office
- 17 of language access include: needs assessments, assistance with

- 1 language access plans, training of agency staff, work with
- 2 interpreters and translators, data collection, reporting, and
- 3 more. The office of language access also conducts periodic
- 4 compliance monitoring, provides complaint resolution, and
- 5 reports annually to the governor and the legislature.
- 6 Due to the State's reduction-in-force in 2009, the office
- 7 of language access's staff of six was eliminated, leaving only
- 8 the executive director position. Although two of the six
- 9 positions were restored in 2013, critical staff positions remain
- 10 unfilled.
- 11 Furthermore, Act 217, Session Laws of Hawaii 2013, also
- 12 created the statewide language access resource center within the
- 13 office of language access. The delay and timing of the
- 14 executive branch's release of funds to staff the resource center
- 15 made it impossible to fill the positions established by that
- 16 Act. The objectives of the statewide language access resource
- 17 center are laudable, but require significant time and resources
- 18 for planning, coordination, and management. The existing office
- 19 of language access staff expended great efforts and resources to
- 20 get the statewide language access resource center off the ground

- 1 -- work that was envisioned to be the responsibilities of new
 2 center staff who have yet to be hired.
- 3 As a result, the office of language access has not been
- 4 able to fully perform its original statutorily-mandated
- 5 compliance and technical assistance functions. Accordingly,
- 6 many state agencies have been unable to implement important
- 7 aspects of their language access plans because of lack of
- 8 oversight and technical assistance, and many limited English
- 9 proficient individuals in Hawaii continue to lack meaningful
- 10 access to government services, programs, and activities.
- 11 The purpose of this Act is to establish three full-time
- 12 equivalent (3.0 FTE) permanent positions within the office of
- 13 language access, as originally specified in the office's
- 14 implementing legislation, to assist state agencies and state-
- 15 funded agencies in implementing the requirements of Hawaii's
- 16 language access law.
- 17 SECTION 2. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$200,000 or so much
- 19 thereof as may be necessary for fiscal year 2016-2017 for three
- 20 full-time equivalent (3.0 FTE) permanent positions within the
- 21 office of language access to assist state agencies and state-

funded agencies in implementing the requirements of Hawaii's 1 2 language access law. Of these three positions: 3 shall be for two full-time equivalent (2.0 (1) 4 FTE) permanent researcher positions; and 5 (2) shall be for one full-time equivalent (1.0 6 FTE) permanent office assistant position. 7 The sum appropriated shall be expended by the department of 8 health for the purposes of this Act. 9 SECTION 3. This Act shall take effect on July 1, 2016.
