A BILL FOR AN ACT

RELATING TO THE UNIFORM FIDUCIARY ACCESS TO DIGITAL ASSETS ACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The Hawaii Revised Statutes is amended by 2 adding a new chapter to be appropriately designated and to read 3 as follows: 4 "CHAPTER 5 UNIFORM FIDUCIARY ACCESS TO DIGITAL ASSETS ACT -1 Short title. This chapter may be cited as the 6 S 7 Uniform Fiduciary Access to Digital Assets Act (2015). -2 Definitions. In this chapter: 8 9 "Account" means an arrangement under a terms-of-service 10 agreement in which a custodian carries, maintains, processes, 11 receives, or stores a digital asset of the user or provides 12 goods or services to the user. "Agent" means an attorney-in-fact granted authority under a 13 durable or nondurable power of attorney. 14 15 "Carries" means engages in the transmission of an

- 3 "Conservator" means a person appointed by a court to manage
- 4 the estate of a living individual. The term includes a limited
- 5 conservator.
- 6 "Content of an electronic communication" means information
- 7 concerning the substance or meaning of the communication which:
- 8 (1) Has been sent or received by a user;
- 9 (2) Is in electronic storage by a custodian providing an
- 10 electronic communication service to the public or is
- 11 carried or maintained by a custodian providing a
- remote computing service to the public; and
- 13 (3) Is not readily accessible to the public.
- 14 "Court" means the circuit court in this State having
- 15 jurisdiction in matters relating to powers of attorney, in the
- 16 case of a fiduciary or agent acting under a will or power of
- 17 attorney; a circuit court in this State having jurisdiction in
- 18 matters relating to the affairs of decedents, in the case of a
- 19 personal representative; a circuit court in this State having

- 21 the family court, depending on which court has subject matter

- 2 conservatorship; or a court that has jurisdiction under section

- 4 "Custodian" means a person that carries, maintains,
- 5 processes, receives, or stores a digital asset of a user.
- 6 "Designated recipient" means a person chosen by a user
- 7 using an online tool to administer digital assets of the user.
- 8 "Digital asset" means an electronic record in which an
- 9 individual has a right or interest. The term does not include
- 10 an underlying asset or liability unless the asset or liability
- 11 is itself an electronic record.
- "Electronic" means relating to technology having
- 13 electrical, digital, magnetic, wireless, optical,
- 14 electromagnetic, or similar capabilities.
- "Electronic communication" has the meaning set forth in
- 16 title 18 U.S.C. section 2510(12).
- 17 "Electronic communication service" means a custodian that
- 18 provides to a user the ability to send or receive an electronic
- 19 communication.
- 20 "Fiduciary" means an original, additional, or successor
- 21 personal representative, conservator, agent, or trustee.

- 1 "Information" means data, text, images, videos, sounds,
- 2 codes, computer programs, software, databases, or the like.
- 3 "Online tool" means an electronic service provided by a
- 4 custodian that allows the user, in an agreement distinct from
- 5 the terms-of-service agreement between the custodian and user,
- 6 to provide directions for disclosure or nondisclosure of digital
- 7 assets to a third person.
- 8 "Person" means an individual, estate, business or nonprofit
- 9 entity, public corporation, government or governmental
- 10 subdivision, agency, or instrumentality, or other legal entity.
- "Personal representative" means an executor, administrator,
- 12 special administrator, or person that performs substantially the
- 13 same function under the law of this State other than this
- 14 chapter.
- 15 "Power of attorney" means a record that grants an agent
- 16 authority to act in the place of a principal.
- 17 "Principal" means an individual who grants authority to an
- 18 agent in a power of attorney.
- 19 "Protected person" means an individual for whom a
- 20 conservator has been appointed. The term includes an individual

- 1 for whom an application for the appointment of a conservator is
- 2 pending.
- 3 "Record" means information that is inscribed on a tangible
- 4 medium or that is stored in an electronic or other medium and is
- 5 retrievable in perceivable form.
- 6 "Remote computing service" means a custodian that provides
- 7 to a user computer-processing services or the storage of digital
- 8 assets by means of an electronic communications system, as
- 9 defined in title 18 U.S.C. section 2510(14).
- 10 "Terms-of-service agreement" means an agreement that
- 11 controls the relationship between a user and a custodian.
- 12 "Trustee" means a fiduciary with legal title to property
- 13 under an agreement or declaration that creates a beneficial
- 14 interest in another. The term includes a successor trustee.
- "User" means a person that has an account with a custodian.
- 16 "Will" includes a codicil, testamentary instrument that
- 17 only appoints an executor, and instrument that revokes or
- 18 revises a testamentary instrument.
- 19 § -3 Applicability. (a) This chapter applies to:

1	(1)	A fiduciary acting under a will or power of attorney
2		executed before, on, or after the effective date of
3		this Act;

- 4 (2) A personal representative acting for a decedent who
 5 died before, on, or after the effective date of this
 6 Act;
- 7 (3) A conservatorship proceeding commenced before, on, or . 8 after the effective date of this Act; and
- 9 (4) A trustee acting under a trust created before, on, or after the effective date of this Act.
- 11 (b) This chapter applies to a custodian if the user
 12 resides in this State or resided in this State at the time of
 13 the user's death.
- (c) This chapter does not apply to a digital asset of an employer used by an employee in the ordinary course of the employer's business.
- 17 § -4 User direction for disclosure of digital assets.
- 18 (a) A user may use an online tool to direct the custodian to
- 19 disclose to a designated recipient or not to disclose some or
- 20 all of the user's digital assets, including the content of
- 21 electronic communications. If the online tool allows the user

- 1 to modify or delete a direction at all times, a direction
- 2 regarding disclosure using an online tool overrides a contrary
- 3 direction by the user in a will, trust, power of attorney, or
- 4 other record.
- 5 (b) If a user has not used an online tool to give
- 6 direction under subsection (a) or if the custodian has not
- 7 provided an online tool, the user may allow or prohibit in a
- 8 will, trust, power of attorney, or other record, disclosure to a
- 9 fiduciary of some or all of the user's digital assets, including
- 10 the content of electronic communications sent or received by the
- 11 user.
- 12 (c) A user's direction under subsection (a) or (b)
- 13 overrides a contrary provision in a terms-of-service agreement
- 14 that does not require the user to act affirmatively and
- 15 distinctly from the user's assent to the terms of service.
- 16 § -5 Terms-of-service agreement. (a) This chapter does
- 17 not change or impair a right of a custodian or a user under a
- 18 terms-of-service agreement to access and use digital assets of
- 19 the user.
- 20 (b) This chapter does not give a fiduciary or designated
- 21 recipient any new or expanded rights other than those held by

- 1 the user for whom, or for whose estate, the fiduciary or
- 2 designated recipient acts or represents.
- 3 (c) A fiduciary's or designated recipient's access to
- 4 digital assets may be modified or eliminated by a user, by
- 5 federal law, or by a terms-of-service agreement if the user has
- 6 not provided direction under section -4.
- 7 § -6 Procedure for disclosing digital assets. (a) When
- 8 disclosing digital assets of a user under this chapter, the
- 9 custodian may at its sole discretion:
- 10 (1) Grant a fiduciary or designated recipient full access
- 11 to the user's account;
- 12 (2) Grant a fiduciary or designated recipient partial
- access to the user's account sufficient to perform the
- 14 tasks with which the fiduciary or designated recipient
- is charged; or
- 16 (3) Provide a fiduciary or designated recipient a copy in
- a record of any digital asset that, on the date the
- 18 custodian received the request for disclosure, the
- 19 user could have accessed if the user were alive and
- 20 had full capacity and access to the account.

- 1 (b) A custodian may assess a reasonable administrative
- 2 charge for the cost of disclosing digital assets under this
- 3 chapter.
- 4 (c) A custodian need not disclose under this chapter a
- 5 digital asset deleted by a user.
- 6 (d) If a user directs or a fiduciary requests a custodian
- 7 to disclose under this chapter some, but not all, of the user's
- 8 digital assets, the custodian need not disclose the assets if
- 9 segregation of the assets would impose an undue burden on the
- 10 custodian. If the custodian believes the direction or request
- 11 imposes an undue burden, the custodian or fiduciary may seek an
- 12 order from the court to disclose:
- (1) A subset limited by date of the user's digital assets;
