### A BILL FOR AN ACT

RELATING TO INSURANCE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that insurance companies
- 2 typically cover a thirty- or ninety-day supply of prescription
- 3 contraceptives. However, these coverage requirements may act as
- 4 a barrier for women, especially those who live in rural areas,
- 5 frequently travel, are unable to schedule regular visits to
- 6 health care providers, or are unable to readily pick up their
- 7 prescriptions. The legislature further finds that statewide
- 8 efforts to expand women's access to prescription contraceptives,
- 9 including long-acting reproductive contraceptives, have been
- 10 shown to help decrease unplanned pregnancies.
- 11 The legislature further finds that Oregon recently enacted
- 12 legislation to expand women's access to prescription
- 13 contraception. The law requires women to first obtain a three-
- 14 month supply of prescription contraceptives then allows women to
- 15 fill subsequent prescriptions for a year at a time. The
- 16 legislature concludes that Hawaii should adopt similar
- 17 legislation, which will increase access to prescription

- 1 contraceptive supplies and decrease barriers regarding
- 2 reproductive health care. The legislature notes that the
- 3 American Congress of Obstetricians and Gynecologists and the
- 4 federal Centers for Disease Control and Prevention recommend
- 5 prescribing or supplying up to one year of oral contraceptive
- 6 supplies, based on a woman's preferences and anticipated use.
- Accordingly, the purpose of this Act is to expand access to
- 8 prescription contraceptives by requiring insurers to cover up to
- 9 a twelve-month period of prescription contraceptive supplies for
- 10 an insured.
- 11 The legislature notes that the reimbursement for
- 12 prescription contraceptive supplies required under this Act is
- 13 intended to apply to all insurers in the State, including health
- 14 benefits plans under chapter 87A, Hawaii Revised Statutes, and
- 15 medicaid managed care programs.
- SECTION 2. Section 431:10A-116.6, Hawaii Revised Statutes,
- 17 is amended to read as follows:
