A BILL FOR AN ACT

RELATING TO PUBLIC HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 46, Hawaii Revised Statutes, is amended
- 2 by adding a new section to be appropriately designated and to
- 3 read as follows:
- 4 "§46- Housing choice voucher program. No county shall
- 5 disqualify a legal nonconforming dwelling unit from the housing
- 6 choice voucher program if the unit meets zoning and building
- 7 code requirements and other program standards such as health and
- 8 safety standards."
- 9 SECTION 2. Section 356D-13.5, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- 11 "[+] §356D-13.5[+] Housing choice voucher program
- 12 administration. (a) Any housing choice voucher program voucher
- 13 issued by the authority shall automatically be returned to the
- 14 authority upon the death or removal from assistance of the last
- 15 original household member; provided that, where the original
- 16 head or co-head of the household is survived by a minor who was
- 17 subsequently added to the household by birth, adoption, or court



- 1 order and the family properly reported the birth, adoption, or
- 2 court order to the authority, the household may retain the
- 3 voucher until the youngest minor added to the household reaches
- 4 the age of twenty-one, or reaches the age of twenty-three if the
- 5 youngest minor is a full-time student at a business school,
- 6 technical school, college, community college, or university. No
- 7 legal guardian shall be added to the household to care for the
- 8 minor or minors unless the legal quardian is also eliqible for
- 9 participation in the housing choice voucher program; provided
- 10 further that any legal quardian added to the household shall not
- 11 retain the voucher after the youngest minor has reached the age
- 12 of twenty-one, or has reached the age of twenty-three if the
- 13 youngest minor is a full-time student at a business school,
- 14 technical school, college, community college, or university.
- 15 (b) The authority shall not disqualify a legal
- 16 nonconforming dwelling unit from the housing choice voucher
- 17 program if the unit meets zoning and building code requirements
- 18 and other program standards such as health and safety
- 19 standards."
- 20 SECTION 3. If any part of this Act is found to be in
- 21 conflict with federal requirements that are a prescribed



- 1 condition for the allocation of federal funds to the State, the
- 2 conflicting part of this Act is inoperative solely to the extent
- 3 of the conflict and with respect to the agencies directly
- 4 affected, and this finding does not affect the operation of the
- 5 remainder of this Act.
- 6 SECTION 4. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 5. This Act shall take effect on July 1, 2050.
