A BILL FOR AN ACT

RELATING TO SEXUAL ASSAULT EVIDENCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 844D, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§844D- Sexual assault evidence; reporting. (a) By
- 5 December 1, 2016, and annually thereafter, all law enforcement
- 6 agencies and departments charged with the maintenance, storage,
- 7 and preservation of sexual assault collection kits shall conduct
- 8 an inventory of all such kits being stored by the agency or
- 9 department.
- (b) By December 1, 2016, and annually thereafter, each law
- 11 enforcement agency and department shall compile, in writing, a
- 12 report containing the number of untested sexual assault
- 13 collection kits in the possession of the agency or department
- 14 and the date the sexual assault collection kit was collected.
- 15 The report shall be transmitted to the attorney general's
- 16 office.

1	(c) By January 1, 2017, and annually thereafter, the
2	department of the attorney general shall prepare and transmit a
3	report to the president of the senate and the speaker of the
4	house of representatives containing the number of untested
5	sexual assault collection kits being stored by each county, by
6	each law enforcement agency or department, and the date the
7	untested kit was collected.
8	(d) As used in this section:
9	"Forensic medical examination" means an examination
10	provided to the victim of a sexually-oriented criminal offense
11	by a health care provider for the purpose of gathering and
12	preserving evidence of a sexual assault for use in a court of
13	law.
14	"Sexual assault collection kit" means a human biological
15	specimen or specimens collected by a health care provider during
16	a forensic medical examination from the victim of a sexually-
17	oriented criminal offense.
18	"Untested sexual assault collection kit" means a sexual
19	assault collection kit that has not been submitted to a
20	qualified laboratory for either a serology or DNA test."
21	SECTION 2. New statutory material is underscored.

SECTION 3. This Act shall take effect upon its approval.
