A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that approximately four
- 2 thousand incoming students are unable to enroll at the
- 3 University of Hawaii because they do not submit health clearance
- 4 forms, which require students to provide documentation of
- 5 immunization for measles, mumps, and rubella.
- 6 The legislature also finds that section 302A-1154, Hawaii
- 7 Revised States, prohibits a child from attending any grade
- 8 school in the State unless the child presents official
- 9 documentation that the child has received immunizations against
- 10 communicable diseases, as required by the department of health.
- 11 The legislature further finds that pursuant to section 11-
- 12 157-3, Hawaii Administrative Rules, students in Hawaii grade
- 13 schools are required to provide schools with documentation of
- 14 immunization from measles, mumps, and rubella.
- 15 The legislature believes that students who have graduated
- 16 from a high school located in the State may reasonably be
- 17 presumed to be immune from measles, mumps, and rubella. The

- 1 legislature therefore finds that it is inefficient and unduly
- 2 burdensome to require a student who has graduated from a high
- 3 school in the State to provide documentation of immunization for
- 4 measles, mumps, or rubella to the University of Hawaii.
- 5 The purpose of this Act is to allow the University of
- 6 Hawaii to enroll a student without documentation of immunization
- 7 for measles, mumps, or rubella if the student pursuing
- 8 enrollment graduated from a high school within the State.
- 9 SECTION 2. Chapter 304A, part II, subpart F, Hawaii
- 10 Revised Statutes, is amended to read as follows:
- "F. [CONTINUING EDUCATION] ENROLLMENT
- 12 [+] §304A-901[+] [Tuberculosis] Health clearance
- 13 [certification; exemption.] provisions; exemptions.
- 14 Notwithstanding any law to the contrary, [a-person] the
- 15 University of Hawaii, with regard to students wishing to enroll
- 16 [at a campus] within the [University of Hawaii] university
- 17 system [solely-to-participate in a noncredit, short-term course,
- 18 lasting less than fifteen days, shall:
- 19 (1) Shall not [be required] require any student to
- 20 present, as a condition to enrollment or otherwise, a
- tuberculosis clearance certification[-] if the student

1		is enrolling solely to participate in a noncredit,
2		short-term course, lasting less than fifteen days; and
3	(2)	May enroll any student who does not present
4		documentation of immunization for measles, mumps, and
5		rubella if the student graduated from a high school
6		within the State."
7	SECTION 3. Statutory material to be repealed is bracketed	
8	and stricken. New statutory material is underscored.	
9	SECT	ION 4. This Act shall take effect upon its approval;
.10	provided that this Act shall apply to persons admitted for	
11	enrollment to the University of Hawaii for a semester beginning	
12	in the fall of 2016 and thereafter.
