## A BILL FOR AN ACT

RELATING TO AQUATIC RESOURCES PENALTIES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 187A-13, Hawaii Revised Statutes, is
amended to read as follows:

3 "\$187A-13 General penalty[-]; community service. (a) Any 4 person violating this chapter or any rule adopted thereunder for 5 which a penalty is not otherwise provided, shall be guilty of a 6 petty misdemeanor and, in addition to any other penalties, shall 7 be fined not less than:

- 8 (1) \$250 for a first offense;
- 9 (2) \$500 for a second offense; and
- 10 (3) \$1,000 for a third or subsequent offense.
- 11 (b) [The fines specified in this section shall not be
- 12 suspended or waived.] The court may require the defendant to
- 13 complete an aquatic resources educational class administered by
- 14 the department in addition to or in lieu of paying all or any
- 15 part of any monetary fine authorized by this section.

5	amended to read as follows:

9	misdemeanor and, in addition to any other penalties, shall be
