# A BILL FOR AN ACT

RELATING TO HEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that children who are
- 2 deaf, hard of hearing, or deaf-blind have the same ability and
- 3 capability to learn language as their peers who do not have a
- 4 similar disability. The ability and right to develop language
- 5 are central to the human experience and necessary prerequisites
- 6 to literacy as well as cognitive, emotional, linguistic,
- 7 academic, and social growth and the chance for children to
- 8 evolve into healthy and productive members of society.
- 9 The legislature further finds that the department of health
- 10 and the department of education are committed to collaborating
- 11 to improve services for children who are deaf, hard of hearing,
- 12 or deaf-blind so that they begin kindergarten with the necessary
- 13 language skills to acquire the knowledge and academic
- 14 competencies that will allow them to be successful in school and
- 15 life.
- 16 The legislature further finds that under the Individuals
- 17 with Disabilities Education Act (IDEA), P.L. 108-446:



1	(1)	The department of health, early intervention section
2		is responsible, under part C, for the provision of
3		early intervention services as identified in the
4		child's individualized family support plan to children
5		from birth to age three years with special needs and
6		their families;
7	(2)	The department of education is responsible, under part
8		B, for the provision of special education and related
9		services as identified in the child's individualized
10		education program to children age three to five years
11		with special needs; and
12	(3)	The executive office on early learning is responsible
13		for coordinating the early childhood education
14		services in the pre-kindergarten program within the
15		public school system.
16	The	legislature further finds that children who are deaf,
17	hard of h	earing, or deaf-blind are diverse and include children
18	with cong	enital or acquired hearing loss, unilateral and
19	bilateral	hearing loss, all degrees of hearing loss from minimal
20	to profou	and, and all types of hearing loss.

2		birth to age five years who are deaf, hard of hearing,
3		or deaf-blind within the department of health to
4		support age-appropriate language development;
5	(2)	Establish a working group for the purposes of
6		investigating issues related to resources and tools
7		for parents of children who are deaf, hard of hearing
8		or deaf-blind and improvements on statewide system of
9		services that support age-appropriate language
10		development for children from birth to age five who
11		are deaf, hard of hearing, or deaf-blind; and
12	(3)	Appropriate funds for two positions to support the
13		early language acquisition program and children from
14		birth to age three years who are deaf, hard of
15		hearing, or deaf-blind.
16	SECT	TION 2. Chapter 321, Hawaii Revised Statutes, is
17	amended b	by adding a new section to part XXVII to be
18	appropria	tely designated and to read as follows:
19	" <u>§32</u>	Early language services for children who are
20	deaf, har	ed of hearing, or deaf-blind. Early intervention
21	services	for infants and toddlers shall include, but not be

- 1 limited to, service providers and mentors of the deaf, hard of
- 2 hearing, or deaf-blind who use American Sign Language; service
- 3 providers and mentors of the deaf who use oral language;
- 4 American Sign Language teachers for families of young children;
- 5 family-to-family support; and training of early intervention
- 6 providers."
- 7 SECTION 3. (a) The department of health, department of
- 8 education, and executive office on early learning shall
- 9 establish and convene a working group for the purpose of making
- 10 recommendations to the legislature on issues related to
- 11 supporting age-appropriate development for children from birth
- 12 to age five years who are deaf, hard of hearing, or deaf-blind.
- 13 The working group shall include the following members to be
- 14 selected by the director of health:
- 15 (1) One parent of a child who is deaf, hard of hearing, or
- deaf-blind who uses American Sign Language;
- 17 (2) One parent of a child who is deaf, hard of hearing, or
- 19 (3) One parent of a child who is deaf, hard of hearing, or
- 20 deaf-blind who uses cochlear implant device;
- 21 (4) One parent of a child who is deaf-blind;

1	(5)	One individual who is deaf, hard of hearing, or deaf-
2		blind who uses American Sign Language;
3	(6)	One individual who is deaf, hard of hearing, or deaf-
4		blind who uses oral language;
5	(7)	One credentialed teacher who uses American Sign
6		Language for children under age six years who are
7		deaf, hard of hearing, or deaf-blind;
8	(8)	One credentialed teacher who uses oral language for
9		children under age six years who are deaf, hard of
10		hearing, or deaf-blind;
11	(9)	One early intervention specialist who works with
12		infants and toddlers using American Sign Language;
13	(10)	One early intervention specialist who works with
14		infants and toddlers using oral language;
15	(11)	One audiologist or speech language pathologist with
16		knowledge of language assessment and intervention for
17		children who are deaf, hard of hearing, or deaf-blind;
18	(12)	One representative from the English as a Second
19		Language community;
20	(13)	One representative from the disability and
21		communication access board:

1	(14)	One representative from the department of health
2		newborn hearing screening program;
3	(15)	One representative from the department of health early
4		intervention section;
5	(16)	One representative from the department of education;
6		and
7	(17)	One representative from the executive office on early
8		learning.
9	Excl	uding the members who are parents of children who are
10	deaf, har	d of hearing, or deaf-blind, the majority of the
11	remaining	members shall be deaf, hard of hearing, or deaf-blind
12	and repre	esent the diversity of their community which includes
13	deaf cult	cure, hard of hearing, cochlear implant and hearing aid
14	users, ur	ilateral hearing loss, auditory neural hearing loss,
15	and cultu	aral diversity. At least one member shall be a
16	represent	ative from the county of Hawaii, Maui, or Kauai. At
17	least one	e parent member shall be deaf, hard of hearing, or deaf-
18	blind. 7	Two parent members shall have children who are deaf,
19	hard of h	nearing, or deaf-blind who are under six years of age at
20	the time	of appointment by the director of health.

1	(b)	The working group shall examine, research, and make
2	recommend	ations to the following:
3	(1)	A resource guide for parents of children who are deaf,
4		hard of hearing, or deaf-blind that may include
5		milestones of age-appropriate language development,
6		websites related to deafness and hearing loss,
7		national and state organizations and resources for
8		families, terms and definitions related to deafness
9		and hearing loss, and communication choices;
10	(2)	Tools used to assess and plan language development
11		services for children from birth to age five years who
12		are deaf, hard of hearing, or deaf-blind;
13	(3)	Data and the availability of data on the language and
14		literacy development for children from birth to age
15		five years who are deaf, hard of hearing, or deaf-
16		blind;
17	(4)	Improvements concerning the statewide system of
18		services that support age-appropriate language
19		development for children from birth to age five years
20		who are deaf, hard of hearing, or deaf-blind; and

1	(5)	Improvements concerning the transition of children at
2		age three years from the department of health early
3		intervention services to the department of education
4		services.
5	(c)	All activities of the departments of health and
6	education	in implementing this section shall be consistent with
7	federal l	aw regarding early intervention and the education of
8	children	with disabilities.
9	(d)	The working group shall submit an interim report of
10	its findi	ngs and recommendations, including any proposed
11	legislati	on and a proposed extension of the working group, to
12	the legis	lature no later than twenty days prior to the convening
13	of the re	egular session of 2017, and a final report of the
14	working g	group's findings and recommendations, including any
15	proposed	legislation, to the legislature no later than twenty
16	days pric	or to the convening of the regular session of 2018.
17	(e)	The working group shall cease to exist on June 30,
18	2018.	
19	SECT	TION 4. There is appropriated out of the general
20	revenues	of the State of Hawaii the sum of \$ or so much
21	thereof a	as may be necessary for fiscal year 2016-2017 to carry

- 1 out the purposes of this Act, for operating expenses and the
- 2 establishment, hiring, and filling of two permanent full-time
- 3 equivalent (2.0 FTE) positions to provide early language
- 4 services for children from birth to three years of age who are
- 5 deaf, hard of hearing or deaf-blind.
- 6 The sums appropriated shall be expended by the department
- 7 of health for the purposes of this Act.
- 8 SECTION 5. New statutory material is underscored.
- 9 SECTION 6. This Act shall take effect on July 1, 2050.

#### Report Title:

Deaf; Hard of Hearing; Deaf-blind; Early Language Services; Working Group; Appropriation

#### Description:

Enhances early language services for children who are deaf, hard of hearing, or deaf-blind. Establishes a working group for the purposes of investigating issues related to resources and tools for parents of children who are deaf, hard of hearing, or deaf-blind and improvements to the statewide system of services that support age-appropriate language development for children from birth to age five who are deaf, hard of hearing, or deaf-blind. Requires working group to report to legislature. Appropriates funds for two positions to support the early language services within the Department of Health. (SB2476 HD1)
