## A BILL FOR AN ACT

RELATING TO FIREWORKS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the transportation 1 of fireworks to, from, and within the State of Hawaii requires 2 the use of multiple modes or methods of transport, including 3 4 interstate trucking or rail, interstate maritime transportation, 5 intrastate maritime transportation, and intrastate trucking. The legislature also finds that, given the diversity of 6 transportation processes and modes, it is essential, and in the 7 best interest of the health and safety of the community and the 8 9 State's first responders, for there to be thorough accounting and reporting on the importation of fireworks shipments. 10 The legislature acknowledges that the current law 11 regulating importation of fireworks establishes requirements for 12 13 licensed individuals or entities in accordance with section 14 132D-8.6, Hawaii Revised Statutes. However, to ensure a more comprehensive tracking of all shipments of fireworks imported 15 16 into the State, additional requirements for those persons or entities defined as "shipper" are necessary. The legislature 17

notes that the requirements for shipper were inadvertently

omitted when this definition was added in a previous legislative 1 2 session. 3 The purpose of this Act is to clarify existing law on fireworks importation by: 4 Delineating the responsibilities of those persons or 5 (1) entities defined as a "shipper"; 6 7 (2) Allowing fireworks to be used in movie or television productions and by those authorized to destroy or test 8 9 fireworks; and Amending the label size requirement for display **10** (3) 11 fireworks, articles pyrotechnic, and aerial devices. SECTION 2. Chapter 132D, Hawaii Revised Statutes, is 12 amended by adding a new section to be appropriately designated 13 and to read as follows: 14 15 "§132D~ Requirements of shipper. Any shipper that receives fireworks that are imported into the State or 16 transported between the counties shall notify the county fire 17 chief of the county to which the shipment is destined, prior to 18 shipment, whether the shipment will be distributed from: 19

(2) Pier to warehouse or storage facility; or

| 7  | cakes, shall bear a permanent label listing the licensee's name, |
| 8  | address, and contact information to include telephone number or  |
| 9  | electronic mail address. The label shall also list the name and  |
| 10 | business address of the manufacturer. The label shall be         |
| 11 | approved by the state fire council and conform to the following  |
| 12 | standards:   |
| 13 | (1) Numerals and letters of the printed matter shall be          |
| 14 | not less than one-eighth of an inch high;                        |
| 15 | (2) Required statements shall be printed in a color that         |
| 16 | contrasts sharply with the background and shall be               |
