#### A BILL FOR AN ACT

RELATING TO WATER INFRASTRUCTURE LOANS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 174C, Hawaii Revised Statutes, is
- 2 amended by adding a new part to be appropriately designated and
- 3 to read as follows:
- 4 "PART . WATER INFRASTRUCTURE LOANS
- 5 §174C-A Definitions. As used in this part:
- 6 "Authority" means the Hawaii water infrastructure authority
- 7 established under section 174C-C.
- 8 "Department" means the department of land and natural
- 9 resources, or any successor by law.
- 10 "Financing order" means any of the costs incurred by the
- 11 department to modify or amend any indenture, financing
- 12 agreement, security agreement, or similar agreement or
- 13 instrument securing any bond or any ancillary agreement.
- 14 "Water infrastructure charge" means the on-bill charges for
- 15 the use and services of the loan program, including the
- 16 repayment of loans made under the loan program to be imposed on
- 17 water utility customers.



- 1 "Water infrastructure costs" means costs incurred or to be
- 2 incurred by the water utility customers to pay for dams,
- 3 reservoirs, hydroelectric pumping, storm water reclamation,
- 4 ditch maintenance, spillways, wells, water ducts, and water
- 5 distribution systems.
- 6 "Water infrastructure equipment" means infrastructure
- 7 improvements, equipment, and personal property to be installed
- 8 for dams, reservoirs, hydroelectric pumping, storm water
- 9 reclamation, ditch maintenance, spillways, wells, water ducts,
- 10 and water distribution systems.
- 11 "Water infrastructure loans" and "loan program" means the
- 12 program established by this part and loans made to finance the
- 13 purchase or installation of water infrastructure equipment for
- 14 dams, reservoirs, hydroelectric pumping, storm water
- 15 reclamation, ditch maintenance, spillways, wells, water ducts,
- 16 and water distribution systems.
- "Water infrastructure special fund" means the special fund
- 18 created pursuant to section 174C-E.
- 19 §174C-B Hawaii water infrastructure loan program. There
- 20 is established a Hawaii water infrastructure loan program, which
- 21 shall be a loan program as defined under section 39-51. The

- 1 program shall be administered by the authority on behalf of the
- 2 department in a manner consistent with chapter 39, part III.
- 3 This loan program may include:
- 4 (1) Loans made to private entities, whether corporations,
- 5 partnerships, limited liability companies, or other
- 6 persons, which entities may lease or provide water
- 7 infrastructure equipment to utility customers; and
- 8 (2) Direct loans to utility customers,
- 9 on terms approved by the authority.
- 10 §174C-C Hawaii water infrastructure authority. There is
- 11 established the Hawaii water infrastructure authority as an
- 12 instrumentality of the State comprising five members. The
- 13 chairperson of the board of land and natural resources, the
- 14 chairperson of the water resource management, and the director
- 15 of finance shall be members of the authority. The governor
- 16 shall appoint the other two members, pursuant to section 26-34.
- 17 The chairperson of the board of land and natural resources shall
- 18 be the chairperson of the authority. The authority shall be
- 19 placed within the department for administrative purposes,
- 20 pursuant to section 26-35; provided that until the authority is
- 21 duly constituted, the department may exercise all powers

- §174C-D Functions, powers, and duties of the authority.
- 4 (a) In the performance of, and with respect to the functions,
- 5 powers, and duties vested in the authority by this part, the
- 6 authority, as directed by the chairperson of the board of land
- 7 and natural resources, may:
- 8 (1) Make loans and expend funds to finance the purchase or 9 installation of water infrastructure equipment for
- 10 dams, reservoirs, hydroelectric pumping, storm water
- 11 reclamation, ditch maintenance, spillways, wells,
- water ducts, and water distribution systems;
- 13 (2) Hold and invest moneys in the water infrastructure
- 14 special fund in investments as permitted by law;
- 15 (3) Hire employees necessary to perform its duties,
- including an executive director. The executive
- 17 director shall be appointed by the authority, and the
- 18 employees' positions, including the executive
- 19 director's position, shall be exempt from chapter 76;
- 20 (4) Enter into contracts for the service of consultants
- 21 for rendering professional and technical assistance

1		and advice, and any other contracts that are necessary			
2		and proper for the implementation of the loan program			
3	(5)	Enter into contracts for the administration of the			
4		loan program, without the necessity of complying with			
5		chapter 103D;			
6	(6)	Establish loan program guidelines to carry out the			
7		purposes of this part;			
8	(7)	Be audited at least annually by a firm of independent			
9		certified public accountants selected by the			
10		authority, and provide the results of this audit to			
11		the department; and			
12	(8)	Perform all functions necessary to effectuate the			
13		purposes of this part.			
14	(b)	The authority shall submit to the board of land and			
15	natural r	esources an annual plan for review and approval no			
16	later tha	n ninety days prior to the start of each fiscal year.			
17	The annua	l plan submitted by the authority shall include the			
18	authority's projected operational budget for the succeeding				
19	fiscal year.

2	There is	established the Hawaii water infrastructure special
3	fund into	which shall be deposited:
4	(1)	Water infrastructure charges received for the use and
5		services of the loan program, including the repayment

7	(2)	All other funds received by the department or the
8		authority and legally available for the purposes of
9		the water infrastructure special fund;
10	(3)	Interest earnings on all amounts in the water
11		infrastructure special fund; and
12	(4)	Any other moneys permitted by the board of land and
13		natural resources.
14	The	Hawaii water infrastructure special fund shall not be
15	subject t	o section 37-53.
16	(b)	Moneys in the Hawaii water infrastructure special fund
17	may be us	ed for the purposes of:
18	(1)	Making water infrastructure loans;
19	(2)	Paying administrative costs of the Hawaii water
20		infrastructure loan program; or

- (3) Paying any other costs related to the Hawaii water
  infrastructure loan program.
- 3 (c) The authority may invest funds held in the Hawaii
- 4 water infrastructure special fund in investments as permitted by
- 5 law. All amounts in the Hawaii water infrastructure special
- 6 fund shall be exempt from all taxes and surcharges imposed by
- 7 the State or the counties.
- 8 §174C-F Use of Hawaii water infrastructure special fund;
- 9 application. (a) The authority shall apply to the board of
- 10 land and natural resources for directives to effectuate the
- 11 Hawaii water infrastructure loan program.
- 12 (b) An application for a directive shall be submitted by
- 13 the authority to the board of land and natural resources.
- 14 (c) In accordance with an approved water infrastructure
- 15 loan program directive or directives, the authority shall
- 16 utilize the amounts deposited in the Hawaii water infrastructure
- 17 special fund pursuant to section 174C-E, to pay financing costs.
- 18 (d) The authority shall obtain approval from the board of
- 19 land and natural resources to direct county water utilities to
- 20 serve as agents to bill and collect the water infrastructure

11	land and natural resources for the purposes of this Act.
12	SECTION 3. There is appropriated out of the general
13	revenues of the State of Hawaii the sum of \$ or so
14	much thereof as may be necessary for fiscal year 2016-2017 for
15	distribution to the counties in the following allocations:
16	(1) City and county of Honolulu \$
17	(2) County of Hawaii \$
18	(3) County of Kauai \$
19	(4) County of Maui \$

- 1 in order for the State to fulfill its constitutional
- 2 requirements under article VIII, section 5, of the state
- 3 constitution.
- 4 The sums appropriated shall be expended by the respective
- 5 counties for the purposes of this Act.
- 6 SECTION 4. In codifying the new sections added by
- 7 section 1 of this Act, the revisor of statutes shall substitute
- 8 appropriate section numbers for the letters used in designating
- 9 the new sections in this Act.

10 SECTION 5. This Act shall take effect on July 1, 2016.
