### A BILL FOR AN ACT

RELATING TO NON-GENERAL FUNDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The purpose of this Act is to repeal and
3	abolish various non-general funds pursuant to the
4	recommendations made by the auditor in auditor's report no. 15-
5	17.
6	PART II
7	SECTION 2. The purpose of this part is to repeal the early
8	intervention trust fund.
9	The legislature finds that the fund does not serve the
10	purpose for which it was created and does not meet the criteria
11	for a trust fund.
12	SECTION 3. Section 321-356, Hawaii Revised Statutes, is
13	repealed.
14	[" <del>\$321-356 Early intervention trust fund. (a) -There is</del>
15	established in the state treasury a trust fund to be known as
16	the early intervention trust fund to be administered by the
17	department in-accordance with this section.

1 (b) The trust fund shall consist of government grants and 2 private contributions including but not limited to gifts or 3 donations from corporations or other businesses, foundations, 4 individuals, and other interested parties, and income earned by 5 the trust fund. All program income consisting of federal 6 reimbursement funds received by the State for early intervention 7 funded by private donations and contributions under this part shall be deposited into the trust fund."] 8 9 SECTION 4. Section 321-357, Hawaii Revised Statutes, is 10 amended as follows: 11 1. By amending its title and subsection (a) to read: 12 "[+]\$321-357[+] Early intervention [funds;] special fund; 13 purpose and use. (a) The purpose of the early intervention special fund [and early intervention trust fund] is to expand 14 and enhance early intervention services for infants and toddlers 15 with special needs by providing a cooperative funding mechanism 16 17 between the public and private sectors to work together to make 18 and secure appropriations and donations to the funds." 19 2. By amending subsection (d) to read:

4	SECT	ION 5. On July 1, 2016, all unencumbered balances
5	remaining	in the early intervention trust fund repealed by
6	section 3	of this Act shall lapse to the credit of the general
7	fund.

11		administratively established in fiscal year 2011-2012
12		and administered by the department of health;

15		without any financial activity since 2007;
16	(3)	The grant for emergency room subsidy at Wai'anae Coast
17		Clinic special fund administratively established and
18		without any financial activity since 2007;
19	(4)	The grant for Hawai'i Primary Care Association Dental
20		special fund administratively established and without
21		any financial activity since 2007;

1	(5)	The hospital-based poison center special fund
2		administratively established and without any financial
3		activity since 2006;
4	(6)	The program for all inclusive care for elderly special
5		fund administratively established and without any
6		financial activity since 2006;
7	(7)	The resources to nonprofit, community-based health
8		care special fund administratively established and
9		without any financial activity since 2006; and
10	(8)	The subsidy for St. Francis Medical Center-Bone Marrow
11		special fund administratively established and without
12		any financial activity since 2007;
13	and any r	emaining unencumbered balances shall be transferred to
14	the gener	al fund.

16	SECT	ION 7. The following funds and accounts are abolished:
17	(1)	The funding for grant pursuant to chapter 42F, Hawaii
18		Revised Statutes, special fund administratively
19		established in 2010 for moneys appropriated from the
20		emergency and budget reserve fund through Act 191,
21		Session Laws of Hawaii 2010, and Act 25, Session Laws

1		of Hawaii 2011, which extended the lapse date to the
2		end of fiscal year 2011-2012;
3	(2)	The healthy aging partnerships program special fund
4		administratively established in 2010 for moneys from
5		the emergency and budget reserve fund authorized
6		through Act 191, Session Laws of Hawaii 2010, for
7		fiscal year 2010-2011 and Act 25, Session Laws of
8		Hawaii 2011, which extended the lapse date from June
9		30, 2011, to June 30,2012; and
10	(3)	The partnership in community living program special
11		fund administratively established in 2010 for moneys
12		appropriated from the emergency and budget reserve
13		special fund through Act 191, Session Laws of Hawaii
14		2010, and Act 25, Session Laws of Hawaii 2011, which
15		extended the lapse date to the end of fiscal year
16		2011-2012;
17	and any r	emaining unencumbered balances shall be transferred to
18	the emerg	ency and budget reserve fund established pursuant to
19	section 3	28L-3, Hawaii Revised Statutes.

- 1 SECTION 8. The Hilo Shippers' Wharf Committee Charitable
- 2 trust fund established pursuant to third circuit court vesting
- 3 order trust no. 03-1-0010 is abolished and any remaining
- 4 unencumbered balance shall be transferred to the county of
- 5 Hawaii.

- 7 SECTION 9. Statutory material to be repealed is bracketed
- 8 and stricken. New statutory material is underscored.
- 9 SECTION 10. This Act shall take effect on July 1, 2016.
