A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 302A, Hawaii Revised Statutes, is		
2	amended by adding a new section to be appropriately designated		
3	and to read as follows:		
4	"§302A-A Student loan subsidy program for teachers;		
5	established; administration. (a) There is established a		
6	student loan subsidy program, to be administered by the		
7	department, to provide financial support to teachers who provide		
8	instruction in:		
9	(1) Special education; or		
10	(2) Vocational education, technical education, or career		
11	path programs.		
12	(b) To be eligible to receive a student loan subsidy under		
13	subsection (a), the recipient shall agree to teach in the public		
14	schools for a minimum of three years continuously.		
15	(c) The department may award a subsidy to any eligible		
16	teacher upon confirmation that the teacher has been employed by		
17	the department to provide instruction in an approved content

area enumerated under subsection (a).

1	<u>(d)</u>	Subsidies under this section may be used only for
2	repayment	of federal, state, or private student loans; provided
3	that a su	bsidy shall not exceed \$10,000.
4	(e)	The department shall determine eligibility on a
5	competiti	ve basis and based on the financial need of the
6	applicant	<u>.</u>
7	<u>(f)</u>	An applicant for a student loan subsidy shall:
8	(1)	Show proof of employment in an approved content area
9		as enumerated under subsection (a);
10	(2)	Comply with any conditions placed by the department on
11		the subsidy;
12	(3)	Demonstrate financial need for a subsidy to the extent
13		as required by the department; and
14	(4)	Submit an application, information, and documentation
15		as required by the department.
16	<u>(g)</u>	If a teacher receiving a student loan subsidy
17	terminate	s employment in an approved content area as enumerated
18	under sub	section (a) during the academic year in which a student
19	loan subs	idy is received, the teacher shall notify the
20	departmen	t in writing and shall return to the department the

- 1 total of any unused portion of the subsidy. Any returned amount
- 2 shall be used by the department to provide other subsidies.
- 3 (h) The total amount of subsidies under this section shall
- 4 be limited to the balance of funds contained in the student loan
- 5 subsidy program special fund under section 302A-B.
- 6 (i) The department shall monitor and verify a teacher's
- 7 continued eligibility and fulfillment of all work requirements
- 8 under this section.
- 9 (j) The department shall adopt policies and procedures in
- 10 accordance with chapter 91 for purposes of this section;
- 11 provided that the department shall be exempt from the public
- 12 notice requirement and public hearing requirement under section
- 13 91-3 for purposes of this subsection."
- 14 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
- 15 amended by adding a new section to be appropriately designated
- 16 and to read as follows:
- 17 "§302A-B Student loan subsidy program special fund. (a)
- 18 There is established within the state treasury a student loan
- 19 subsidy program special fund for the purpose of providing
- 20 subsidies to qualifying teacher under the student loans subsidy
- 21 program under section 302A-A.

- 1 (b) Moneys in the fund shall be comprised of
- 2 appropriations, private contributions, and moneys from other
- 3 sources. The balance of moneys in the fund at the close of each
- 4 fiscal year shall remain in the fund and shall not lapse into
- 5 the general fund."
- 6 SECTION 3. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$5,000,000 or so much
- 8 thereof as may be necessary for fiscal year 2016-2017 to be
- 9 deposited into the student loan subsidy program special fund
- 10 established pursuant to section 2 of this Act.
- 11 The sum appropriated shall be expended by the department of
- 12 education for the purposes of this Act.
- 13 SECTION 4. There is appropriated out of the student loan
- 14 subsidy program special fund the sum of \$ or so much
- 15 thereof as may be necessary for fiscal year 2016-2017 for the
- 16 student loan subsidy program.
- 17 The sum appropriated shall be expended by the department of
- 18 education for the purposes of this Act.
- 19 SECTION 5. In codifying the new sections added by sections
- 20 1 and 2 of this Act, the revisor of statutes shall substitute

- 1 appropriate section numbers for the letters used in designating
- 2 the new sections in this Act.
- 3 SECTION 6. New statutory material is underscored.
- 4 SECTION 7. This Act shall take effect on July 1, 2016.
