### A BILL FOR AN ACT

RELATING TO TECHNOLOGY IN SCHOOLS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 302A, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be designated and to read as
- 3 follows:
- 4 "§302A- Curricular materials; digital format. (a) A
- 5 publisher or manufacturer that submits printed curricular
- 6 materials to be used in public schools on or after July 1, 2016,
- 7 shall ensure that such printed curricular materials are also
- 8 available in an equivalent digital format during the entire
- 9 period in which the printed curricular materials are being used
- 10 by the public schools.
- (b) Moneys allocated for printed curricular materials may
- 12 also be expended to purchase digital formats of the curricular
- 13 materials."
- 14 SECTION 2. Section 302A-101, Hawaii Revised Statutes, is
- 15 amended as follows:
- 16 1. By adding a new definition to be appropriately
- 17 inserted and to read:

""Curricular materials" means any systematically organized 1 material designed to provide a specific level of instruction in 2 a subject-matter category, including textbooks, instructional 3 materials, library books, equipment, computer software, digital 4 content accessed through a computer or other electronic medium, 5 digital content available through an internet-based provider of 6 course content, or supplies used in a particular course of 7 8 study." 9 By repealing the definition of "school textbooks, 10 instructional materials, library books, equipment, or supplies". ["#School textbooks, instructional materials, library 11 books, equipment, or supplies" includes any book, printed 12 13 matter, or other material used in a particular course of 14 study."] SECTION 3. Section 302A-1130.6, Hawaii Revised Statutes, 15 is amended to read as follows: 16 17 "§302A-1130.6 [Textbook and instructional] Curricular materials fee special account. There is established within the 18 department a [textbook and instructional] curricular materials 19 fee special account, into which shall be deposited all fees and 20 charges collected from students or their parents or guardians 21

- 4 special account shall be expended by the department for the

- 8 SECTION 4. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$12,800,000 or so
- 10 much thereof as may be necessary for fiscal year 2016-2017 for
- 11 digital devices for teachers and students to use in public
- 12 school classrooms.
- 13 The sum appropriated shall be expended by the department of
- 14 education for the purposes of this Act.
- 15 SECTION 5. Statutory material to be repealed is bracketed
- 16 and stricken. New statutory material is underscored.
- 17 SECTION 6. This Act shall take effect upon its approval;
- 18 provided that section 4 shall take effect on July 1, 2016.

### Report Title:

Technology in Schools; Digital Format; Appropriation

#### Description:

Defines curricular materials to include both printed and digital material. Requires textbook manufacturers to make a digital format of the textbook available for use in public schools. Clarifies that moneys for curricular materials can be used for digital formats. Appropriates funds.
