## A BILL FOR AN ACT

RELATING TO MINORS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that being lesbian, gay, 2 bisexual, or transgender is not a disease, disorder, illness,
- 3 deficiency, or shortcoming. Major professional associations of
- 4 mental health practitioners and researchers in the United States
- 5 have recognized this fact for nearly forty years.
- 6 The American Psychological Association convened a task
- 7 force on appropriate therapeutic responses to sexual
- 8 orientation. The task force conducted a systematic review of
- 9 peer-reviewed journal literature on sexual orientation change
- 10 efforts. The task force concluded that sexual orientation
- 11 change efforts can pose critical health risks to lesbian, gay,
- 12 and bisexual individuals, including confusion, depression,
- 13 guilt, helplessness, shame, social withdrawal, suicide,
- 14 substance abuse, and other negative feelings and behaviors.
- 15 The legislature further finds that other studies confirm
- 16 the serious health risks that minors face when they experience
- 17 family rejection based on their sexual orientation. In one

- 1 levels of family rejection during adolescence were 8.4 times
- 2 more likely to report having attempted suicide, 5.9 times more
- 3 likely to report high levels of depression, 3.4 times more
- 4 likely to use illegal drugs, and 3.4 times more likely to report
- 5 having engaged in unprotected sexual intercourse compared with
- 6 peers from families that reported no or low levels of family
- 7 rejection. The legislature therefore concludes that all minors,
- 8 especially lesbian, gay, bisexual, and transgender minors who
- 9 experience family rejection, should be protected against sexual
- 10 orientation change efforts by counseling professionals.
- 11 The purpose of this Act is to protect the physical and
- 12 psychological well-being of minors, including lesbian, gay,
- 13 bisexual, and transgender youth, against exposure to serious
- 14 harms caused by sexual orientation change efforts.
- 15 SECTION 2. Chapter 436B, Hawaii Revised Statutes, is
- 16 amended by adding a new section to be appropriately designated
- 17 and to read as follows:
- 18 "S436B- Sexual orientation change efforts prohibited;
- 19 advertising prohibited. (a) No person who is licensed to
- 20 provide professional counseling, including but not limited to a
- 21 physician specializing in the practice of psychiatry, physician

- 1 assistant, psychologist, social worker, mental health counselor,
- 2 marriage and family therapist, or a person who performs
- 3 counseling as part of the person's professional training for any
- 4 of these professions, shall:
- 5 (1) Engage in sexual orientation change efforts on a person under eighteen years of age; or
- 7 (2) Advertise the offering of sexual orientation change 8 efforts on a person under eighteen years of age.
- (b) Any person who is licensed to provide professional

  counseling who attempts to engage in sexual orientation change

  efforts or advertises the offering of sexual advertising change

  efforts on a person under eighteen years of age shall be subject

  to disciplinary action by the appropriate professional licensing
- (c) In addition to the penalties under subsection (b),

  advertising the offering of sexual advertising change efforts on

  a person under eighteen years of age shall constitute an unfair

  or deceptive act or practice under section 480-2.
- (d) For the purposes of this section, "sexual orientation change efforts" means the practice of attempting to change a person's sexual orientation, including but not limited to

1	efforts to change behaviors, gender identity, or gender
2	expressions; or to reduce or eliminate sexual or romantic
3	attractions or feelings toward a person of the same gender.
4	"Sexual orientation change efforts" shall not include
5	counseling for a person seeking to transition from one gender to
6	another or counseling that:
7	(1) Provides acceptance, support, and understanding of a
8	person or facilitates a person's coping, social
9	support, and identity exploration and development,
10	including sexual orientation-neutral interventions to
11	prevent or address unlawful conduct or unsafe sexual
12	practices; and
13	(2) Does not seek to change sexual orientation."
14	SECTION 3. This Act does not affect rights and duties that
15	matured, penalties that were incurred, and proceedings that were
16	begun before its effective date.
17	SECTION 4. New statutory material is underscored.
18	SECTION 5. This Act shall take effect upon its approval.

## Report Title:

Conversion Therapy; Sexual Orientation; Minors

## Description:

Prohibits persons licensed to provide professional counseling from engaging in or advertising sexual orientation change efforts on students and persons under eighteen years of age. Makes advertising the offering of sexual orientation change efforts an unfair or deceptive act or practice. (SD1)
