A BILL FOR AN ACT

RELATING TO VOTING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 11, Hawaii Revised Statutes, is amended
- 2 by adding a new section to part II to be appropriately
- 3 designated and to read as follows:
- 4 "S11-A Automatic registration. (a) Notwithstanding any
- 5 law to the contrary, an affidavit on an application for voter
- 6 registration shall be a part of the application associated with
- 7 the issuance of a civil identification card under section
- 8 286-301 and a driver's license under section 286-109. For
- 9 purposes of this section, the affidavit shall meet the
- 10 requirements of section 11-15.
- 11 (b) Applications for an identification card or driver's
- 12 license shall not be processed until the applicant either
- 13 clearly indicates on the application that the applicant declines
- 14 to register to vote or completes the portion of the application
- 15 related to voter registration. Each application shall include a
- 16 space to request a permanent absentee ballot.

1	(c) The examiner of drivers of each county shall transmit
2	the completed voter registration information to the clerk of the
3	county in which the applicant resides. Upon receipt of the
4	completed voter registration application transmitted from the
5	examiner of drivers, the county clerk shall review and either
6	approve or reject the voter registration application in
7	accordance with this part; provided that approved voter
8	registration applications received from the examiner of drivers
9	pursuant to this section shall be treated as having a valid
10	signature for purposes of section 11-15(c) whether transmitted
11	electronically or by facsimile transmission. Upon approval of
12	the voter registration application, the clerk shall proceed to
13	number the application and register the name of the voter in the
14	general county register as provided in section 11-15."
15	SECTION 2. Chapter 286, Hawaii Revised Statutes, is
16	amended by adding a new section to part VI to be appropriately
17	designated and to read as follows:
18	"§286-A Voter registration. (a) If a qualified applicant
19	for a motor vehicle driver's license opts to register to vote
20	when applying for a driver's license, the voter registration
21	information shall automatically be transmitted to the clerk of

- 1 the appropriate county upon completion of an application for a
- 2 driver's license as required in section 11-A.
- 3 (b) Every qualified applicant who opts to register to vote
- 4 pursuant to the process established under subsection (a) and
- 5 section 11-A shall be required to authorize the examiner of
- 6 drivers to collect and transmit the necessary personal
- 7 information required for registering the qualified applicant
- 8 with the county clerk. The examiner of drivers shall notify all
- 9 qualified applicants who opt to vote pursuant to the process
- 10 established under subsection (a) and section 11-A that, by
- 11 opting to register to vote and submitting an application for a
- 12 driver's license, provisional license, or instructional permit,
- 13 the qualified applicant is consenting to the automatic
- 14 application to vote with the county clerk.
- 15 (c) For the purposes of this section, "qualified
- 16 applicant" means a person who qualifies to register as a voter
- 17 pursuant to section 11-15."
- 18 SECTION 3. Chapter 286, Hawaii Revised Statutes, is
- 19 amended by adding a new section to part XVI to be appropriately
- 20 designated and to read as follows:

1 "§286-B Voter registration. (a) If a qualified applicant 2 for a new, renewal, or duplicate civil identification card opts 3 to register to vote when applying for a new, renewal, or duplicate civil identification card, the voter registration 4 information shall automatically be transmitted to the clerk of 5 6 the appropriate county upon completion of an application for a 7 civil identification card as required by section 11-A. 8 (b) Every qualified applicant who opts to register to vote 9 pursuant to the process established under subsection (a) and 10 section 11-A shall be required to authorize the examiner of drivers to collect and transmit the necessary personal 11 information required for registering the qualified applicant 12 with the county clerk. The examiner of drivers shall notify all 13 qualified applicants who opt to register to vote pursuant to the 14 15 process established under subsection (a) and section 11-A that, by opting to register to vote, and by submitting an application 16 for a new, renewal, or duplicate civil identification card, the 17 qualified applicant is consenting to the automatic application 18 19 to vote with the county clerk.

1	<u>(c)</u>	For the purposes of this section, "qualified
2	applicant	" means a person who qualifies to register as a voter
3	pursuant	to section 11-15."
4	SECT	ION 4. Section 286-108, Hawaii Revised Statutes, is
5	amended b	y amending subsection (a) to read as follows:
6	"(a)	Except as provided in section 286-107.5(a), the
7	examiner	of drivers shall examine every applicant for a driver's
8	license,	except as otherwise provided in this part. The
9	examinati	on shall include a test of:
10	(1)	The applicant's eyesight and any further physical
11		examination that the examiner of drivers finds
12		necessary to determine the applicant's fitness to
13		operate a motor vehicle safely upon the highways;
14	(2)	The applicant's ability to understand highway signs
15		regulating, warning, and directing traffic;
16	(3)	The applicant's knowledge of the rules of the road
17		based on the traffic laws of the State and the traffic
18		ordinances of the county where the applicant resides
19		or intends to operate a motor vehicle; provided that
20		the examination shall specifically test the

1	applicant's knowledge of the provisions of section
2	291C-121.5 and section 291C-137; and
3	(4) The actual demonstration of ability to exercise
4	ordinary and reasonable control in the operation of a
5	motor vehicle.
6	The examinations shall be appropriate to the operation of the
7	category of motor vehicle for which the applicant seeks to be
8	licensed and shall be conducted as required by the director.
9	The examiner of drivers shall require every applicant to
10	comply with section 286-102.5.
11	The examiner of drivers may waive the actual demonstration
12	of ability to operate a motorcycle or motor scooter for any
13	person who furnishes evidence, to the satisfaction of the
14	examiner of drivers, that the person has completed the
15	motorcycle education course approved by the director in
16	accordance with section 431:10G-104.
17	[At the time of examination, an application for voter
18	registration by mail shall be made available to every applicant
19	for a driver's license.]

For the purposes of this section, the term "applicant" does 1 2 not include any person reactivating a license under section 3 286-107.5(a)." SECTION 5. Section 286-109, Hawaii Revised Statutes, is 4 amended to read as follows: 5 "§286-109 General provision governing the issuance of 6 (a) Upon payment of the required fee and upon 7 licenses. demonstrating the ability to operate a certain category or 8 categories of motor vehicles to the satisfaction of the examiner 9 of drivers, an applicant for a driver's license shall be issued 10 a single license of a design approved by the director of 11 transportation upon which is made a notation of: 12 The category or categories of motor vehicles the 13 (1) applicant may operate; 14 Any restrictive provisions to which the license is (2) 15 subject; 16 (3) Veteran status, if desired by the applicant; provided 17 that the notation shall be on the front of the license 18 and shall not include any designation other than the 19 20 term "veteran"; and

1	(4)	When the license is issued to a person under twenty-
2		one years of age, a statement, in clearly legible
3		print that shall contrast with the other information
4		appearing on the license, which indicates the date on
5		which the person will attain the age of twenty-one
6		years.

- As used in this subsection, "veteran" means any person who
 served in any of the uniformed services of the United States and
 was discharged under conditions other than dishonorable.
- 10 (b) The examiner of drivers shall not issue or renew any
 11 driver's license using the driver's social security number on
 12 the driver's license.
 - (c) Statutes of limitations and other provisions of this chapter notwithstanding, no driver's license or instruction permit shall be issued or renewed under this section, where the examiner of drivers is notified by the district judge, traffic violations bureaus of the district courts, or the judge of the circuit court that the applicant has failed to respond to a traffic citation or summons, or failed to appear in court after an arrest for the violation of any traffic laws of a county, this chapter or chapter 286G, 287, 290, 291, or 291C, or of any

motor vehicle insurance laws under article 10C of chapter 431, 1 or of any motorcycle or motor scooter insurance laws under 2 3 article 10G of chapter 431, and the same remains delinquent and outstanding, or the applicant, has as of the time of the 4 application, failed to comply in full with all orders of the 5 court; provided that the district court with whose order an 6 applicant has failed to comply in full, may approve the issuance 7 8 or renewal of a driver's license or instruction permit other 9 than a commercial driver's license upon conditions imposed by 10 the court for the satisfaction of the outstanding court order 11 and any other conditions as may be imposed by the court, if one or more of the following conditions are met: 12 The applicant is gainfully employed in a position that 13 (1) requires driving and will be discharged if the 14 15 applicant is unable to drive; or 16 (2) The applicant has no access to alternative transportation and therefore must drive to work; 17 provided further that if the applicant has failed to comply in 18 19 full with orders of the district court of more than one circuit,

the applicant shall obtain the approval of the district court of

each circuit in which the applicant has an outstanding court

- 1 order before a driver's license or instruction permit may be
- 2 issued or renewed under this subsection.
- 3 A driver's license or instruction permit issued or renewed
- 4 under this subsection shall be subject to immediate suspension
- 5 by the court upon the applicant's failure to remain in full
- 6 compliance with all conditions imposed by the court for the
- 7 issuance or renewal of the driver's license or instruction
- 8 permit. The examiner of drivers may place an indication of
- 9 restriction upon a driver's license or instruction permit issued
- 10 or renewed under this subsection. Proof of financial
- 11 responsibility under section 287-20 shall not apply to the
- 12 issuance or renewal of driver's licenses or instruction permits
- 13 under this subsection.
- 14 (d) An application for a driver's license shall include
- 15 the information required under section 11-A."
- 16 SECTION 6. Section 286-301, Hawaii Revised Statutes, is
- 17 amended to read as follows:
- 18 "[+] §286-301[+] Issuance of identification card or
- 19 temporary card. (a) To obtain an identification card from the
- 20 examiner of drivers, an individual shall complete an application
- 21 pursuant to section 286-303.

- 1 (b) The examiner of drivers, upon receipt of the
- 2 application by any individual who is a resident or a temporary
- 3 resident of this State, shall issue an identification card to
- 4 that individual upon receipt of any appropriate fee established
- 5 pursuant to section 286-309.
- 6 (c) The identification card shall be similar in size,
- 7 shape, and design to a driver's license, but shall not entitle
- 8 the individual to whom it is issued to operate a motor vehicle.
- 9 (d) The issuance of an identification card pursuant to
- 10 this section shall not place upon the State of Hawaii or any
- 11 agency any liability for the misuse or the acceptance of the
- 12 identification card as valid identification, which shall be left
- 13 entirely to the discretion of any individual to whom such card
- 14 is presented.
- 15 (e) An application for an identification card from the
- 16 examiner of drivers shall include the information required under
- 17 section 11-A."
- 18 SECTION 7. Section 286-311, Hawaii Revised Statutes, is
- 19 amended by amending subsection (a) to read as follows:
- 20 "(a) [All] Except for purposes of sections 286-A, 286-B,
- 21 286-109, and 286-301, information and records acquired by the



1 examiner of drivers under this part shall be confidential. All 2 information and records shall be maintained in an appropriate 3 form and in an appropriate office in the custody and under the 4 control of the examiner. The information shall be available 5 only to authorized individuals under such restrictions as the 6 director shall prescribe. The examiner may dispose of any 7 application or identification card, or information or record 8 relating to the application or identification card, which does 9 not include a social security number, without regard to chapter 10 94, whenever, in the examiner's discretion, retention of the 11 information or record is no longer required or practicable." In codifying the new sections added by sections 12 SECTION 8. 1, 2, and 3 of this Act, the revisor of statutes shall 13 14 substitute appropriate section numbers for the letters used in 15 designating the new sections in this Act. 16 SECTION 9. Statutory material to be repealed is bracketed and stricken. New statutory material is underscored. 17 18 This Act shall take effect on upon approval. SECTION 10. 19

Description:

Provides that an applicant for a driver's license or civil identification card must clearly opt out from voter registration or fill out the voter affidavit on the application before it can be processed. Provides that voter registration will automatically be transmitted to the appropriate county clerk upon the completion of an application for a driver's license or civil identification card unless the applicant opts out.
