A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Unlike other states, Hawaii does not enjoy the
- 2 benefit of being linked to other states, cities, or towns via
- 3 the federal interstate highway system or a network of
- 4 interconnected state and local highways. Air transportation is
- 5 currently the only efficient means of travel between Hawaii's
- 6 major islands. An interisland ferry system can serve as an
- 7 efficient alternative for transporting passengers, cargo, farm
- **8** produce, and motor vehicles.
- 9 Washington State Ferries, which is part of the Washington
- 10 State Department of Transportation, operates the largest ferry
- 11 system in the United States. Washington State Ferries employs
- 12 approximately eighteen hundred people and is Washington's most
- 13 popular tourist attraction. Alaska also has a successful ferry
- 14 system.
- 15 S.R. No. 116, S.D. 1, Regular Session of 2015, adopted on
- 16 April 9, 2015, requests the department of transportation to
- 17 study the feasibility of establishing an interisland ferry

- 1 system, among other things. The department of transportation is
- 2 requested to report on its findings and recommendations to the
- 3 legislature prior to the 2016 regular session. However, the
- 4 department may need additional funding and time to undertake and
- 5 complete the study.
- 6 The purpose of this Act is to require the department of
- 7 transportation to conduct a study on the feasibility of
- 8 establishing an interisland ferry system and to make an
- 9 appropriation for expenses accordingly.
- 10 SECTION 2. The department of transportation shall conduct
- 11 a study on the feasibility of establishing an interisland ferry
- 12 system similar to the ferry systems operated by Washington State
- 13 and other jurisdictions, including proposed legislation. In
- 14 conducting the study, the department shall:
- 15 (1) Include a comparison of various jurisdictions with
- 16 successful ferry systems including Washington and
- 17 Alaska;
- 18 (2) Emphasize compliance of an interisland ferry system
- 19 with the State's environmental protection laws,
- 20 including chapter 343, Hawaii Revised Statutes;

- 3 SECTION 4. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so much
- 5 thereof as may be necessary for fiscal year 2016-2017 for the
- 6 department of transportation to conduct a study on the
- 7 feasibility of establishing an interisland ferry system as
- 8 described in this Act.
- 9 The sum appropriated shall be expended by the department of
- 10 transportation for the purposes of this Act.
- 11 SECTION 5. This Act shall take effect on January 1, 2050.
