A BILL FOR AN ACT

RELATING TO SHARK AND RAY PROTECTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that sharks and rays are
- 2 extremely important to ocean ecosystems. As ocean predators
- 3 near the top of the food chain, sharks keep the ecosystem
- 4 balanced, regulate populations of other marine life, and ensure
- 5 healthy fish stock and reefs.
- 6 Sharks and rays are more vulnerable than most other fish
- 7 species. They are long-lived and slow-growing, start
- 8 reproducing at an advanced age, and produce relatively few
- 9 offspring per year. If the food chain is disrupted by a decline
- 10 in the shark population, it affects the entire reef system.
- 11 Protection for sharks and rays ultimately means healthier, more
- 12 resilient oceans and reefs that are better able to withstand
- 13 other pressures on the ocean ecosystem from climate change and
- 14 pollution.
- 15 Sharks and rays on the reefs not only play important
- 16 ecological roles but are also valued figures in Hawaiian culture
- 17 and are important economically to ocean recreation industries

- 1 and to tourism in Hawaii. The benefits of maintaining viable
- 2 populations greatly outweigh any value that would be gained by
- 3 killing these species.
- 4 The purpose of this Act is to:
- 5 (1) Protect sharks and rays for ecological purposes, for
- 6 their value to the ocean recreation industry, and for
- 7 their value to native Hawaiian cultural practices; and
- 8 (2) Establish fines and penalties for knowingly capturing,
- 9 killing, or taking a shark within state waters.
- 10 SECTION 2. Chapter 188, Hawaii Revised Statutes, is
- 11 amended by adding a new section to be appropriately designated
- 12 and to read as follows:
- 13 "\$188- Sharks; prohibitions; exceptions; penalties and
- 14 fines. (a) Except as provided in subsection (e), or as
- 15 otherwise provided by law, no person shall knowingly capture,
- 16 kill, or take any shark within state marine waters.
- 17 (b) Any person violating this section or any rule adopted
- 18 pursuant to this section shall be guilty of a misdemeanor;
- 19 provided that the fine for violating this section shall be:
- 20 (1) \$500 for a first offense;
- 21 (2) \$2,000 for a second offense; and

1	<u>(3)</u>	\$10,000 for a third or subsequent offense.
2	<u>(c)</u>	In addition to any other penalty imposed under this
3	section,	a person violating this section shall be subject to:
4	(1)	An administrative fine of not more than \$10,000 for
5		each shark captured, killed, or taken in violation of
6		this section;
7	(2)	Seizure and forfeiture of any captured sharks,
8		commercial marine license, vessel, and fishing
9		equipment; and
10	(3)	Assessment of administrative fees and costs, and
11		attorney's fees and costs.
12	<u>(</u> d)	The criminal penalties and administrative fines and
13	costs sha	ll be assessed per shark captured, killed, or taken in
14	violation	of this section.
15	<u>(e)</u>	This section shall not apply to:
16	(1)	Special activity permits allowed under section 187A-6
17		or research permits authorized by law; provided that
18		the permit issued does not allow a take that exceeds
19		the potential biological removal level; provided
20		further that the department of land and natural
21		resources may adopt rules to define "take" for

1	•	purposes of this subsection and determine when a take
2		exceeds the potential biological removal level;
3	(2)	Any person exercising native Hawaiian gathering rights
4		and traditional cultural practices as authorized by
5		law or as permitted by the department pursuant to
6		article XII, section 7, of the Hawaii State
7		Constitution; and
8	(3)	The department or its designated agent if the capture,
9		kill, or take is for the protection of public safety.
10	<u>(f)</u>	For the purposes of this section, "shark" means any
11	species o	f selachimorpha."
12	SECT	ION 3. Section 188-39.5, Hawaii Revised Statutes, is
13	amended t	o read as follows:
14	" [+]	\$188-39.5[] Manta rays; Prohibitions,
15	penalties	, and fines. (a) [Ne] Except as provided by
. 16	subsectio	n (e), no person shall knowingly capture or kill a
17	[manta] r	ay within state marine waters.
18	(b)	Any person violating this section or any rule adopted
19	pursuant	to this section shall be guilty of a misdemeanor and
20	shall be	fined:
21	(1)	\$500 for a first offense;

- 1 (2) \$2,000 for a second offense; and
- 2 (3) \$10,000 for a third or subsequent offense.
- 3 (c) In addition to any other penalty imposed under this
- 4 section, a person violating this section shall be subject to:
- 5 (1) An administrative fine of not more than \$10,000 for
- 6 each [manta] ray captured or killed in violation of
- 7 this section;
- 8 (2) Seizure and forfeiture of any captured [manta] rays,
- 9 commercial marine license, vessel, and fishing
- 10 equipment; and
- 11 (3) Assessment of administrative fees and costs, and
- 12 attorney's fees and costs.
- 13 (d) The criminal penalties and administrative fines and
- 14 costs shall be assessed per [manta] ray captured or killed in
- 15 violation of this section.
- (e) This section shall not prohibit special activity
- 17 permits allowed under section 187A-6[+] or research permits
- 18 authorized by law; provided that the permit issued does not
- 19 allow a take that exceeds the potential biological removal
- 20 level; and provided further that the department [shall] may

- 1 adopt rules to define a "take" and determine when a take exceeds
- 2 the potential biological removal level.
- 3 (f) For the purposes of this section, "ray" means any
- 4 species of Batoidea."
- 5 SECTION 4. Section 188-70, Hawaii Revised Statutes, is
- 6 amended by amending subsection (a) to read as follows:
- 7 "(a) Any person violating any provision of or any rule
- 8 adopted pursuant to this chapter, except sections 188-23 [and],
- 9 188-39.5, and 188- is guilty of a petty misdemeanor and, in
- 10 addition to any other penalties, shall be fined not less than:
- 11 (1) \$100 for a first offense;
- 12 (2) \$200 for a second offense; and
- (3) \$500 for a third or subsequent offense."
- 14 SECTION 5. This Act does not affect rights and duties that
- 15 matured, penalties that were incurred, and proceedings that were
- 16 begun before its effective date.
- 17 SECTION 6. Statutory material to be repealed is bracketed
- 18 and stricken. New statutory material is underscored.
- 19 SECTION 7. This Act shall take effect upon its approval.
