# A BILL FOR AN ACT

RELATING TO INDUSTRIAL HEMP.

	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:
1	SECTION 1. The legislature finds that mankind has
2	cultivated hemp as a source of food and fiber for thousands of
3	years. Modern production methods have utilized hemp's oilseed
4	to make high-grade food and beauty products. The stalks produce
5	fiber and cellulose for everything from automotive parts and
6	fine clothing to building materials and fuel.
7	The legislature further finds that according to estimates
8	by the Hemp Industries Association, retail sales of industrial
9	hemp products in the United States have grown steadily since
^	

10 1990 to more than \$620,000,000 annually in 2014. California

11 manufacturers of hemp products currently import tens of

12 thousands of acres' worth of hemp seed, oil, and fiber products

13 from around the world that could be produced by American farmers

14 at a more competitive price. Additionally, the intermediate

processing of hemp seed, oil, food ingredients, and fiber could

16 create jobs in close proximity to the fields of cultivation.

17 The legislature further finds that support for industrial

- 1 Colorado, Delaware, Hawaii, Illinois, Indiana, Kentucky, Maine,
- 2 Montana, Nebraska, North Dakota, Oregon, South Carolina,
- 3 Tennessee, Utah, Vermont, Washington, and West Virginia have
- 4 defined industrial hemp as a distinct agricultural crop and
- 5 removed barriers to its production. Furthermore, President
- 6 Obama signed the 2014 Farm Bill into law, which authorizes
- 7 industrial hemp research and pilot programs in states that
- 8 regulate hemp farming under the authority of the state
- 9 department of agriculture. This relaxation of the federal
- 10 government's prohibition signals that hemp is poised to once
- 11 again become a lucrative industrial crop in the United States.
- 12 The purpose of this Act is to establish an industrial hemp
- 13 pilot program to allow the cultivation of industrial hemp and
- 14 distribution of its seed in Hawaii through limited activities by
- 15 the board of agriculture through a pilot program for purposes of
- 16 agricultural or academic research.
- 17 SECTION 2. Chapter 141, Hawaii Revised Statutes, is
- 18 amended by adding a new part to be appropriately designated and
- 19 to read as follows:
- 20 "PART . INDUSTRIAL HEMP PILOT PROGRAM
- 21 §141-A Definitions. As used in this part:

- 1 "Applicant" means a person that is an individual residing
- 2 in Hawaii or an institution of higher education, a sole
- 3 proprietorship, partnership, association, corporation, limited-
- 4 liability corporation, limited partnership, or any other
- 5 business entity having any:
- 6 (1) Place of business permanently located within the
- 7 State;
- 8 (2) Employees permanently assigned to work stations or
- 9 areas located within the State; or
- 10 (3) Tangible assets permanently located within the State.
- 11 "Board" means the board of agriculture.
- 12 "Chairperson" means the chairperson of the board of
- 13 agriculture.
- "Industrial hemp" means the plant Cannabis sativa L. and
- 15 any part of that plant, whether growing or not, with a delta-9
- 16 tetrahydrocannabinol concentration of not more than 0.3 per cent
- 17 on a dry weight basis or a tetrahydrocannabinol concentration
- 18 allowed by federal law, whichever is greater, that is
- 19 cultivated.
- 20 "Seed cultivar" means a variety of industrial hemp.

- 1 "Variety" means a group of individual plants that exhibit
- 2 the same observable physical characteristics or have the same
- 3 genetic composition.
- 4 §141-B Industrial hemp pilot program; established. (a)
- 5 There is established within the department of agriculture an
- 6 industrial hemp pilot program to allow the cultivation of
- 7 industrial hemp and distribution of its seed in Hawaii through a
- 8 pilot program for purposes of agricultural or academic research.
- 9 The industrial hemp pilot program may be conducted on multiple
- 10 test sites.
- 11 (b) In order to acquire industrial hemp seed for the pilot
- 12 program, the department of agriculture shall register with the
- 13 United States Department of Justice, Drug Enforcement
- 14 Administration, as an importer of controlled substances.
- 15 (c) The pilot program shall establish an agency
- 16 relationship with licensees, who operate as extensions of the
- 17 board for the purposes of research on the growth, cultivation,
- 18 and marketing of industrial hemp.
- 19 (d) The board shall make a reasonable effort to:
- 20 (1) Inform licensees of the laws and regulations
- 21 applicable to the production of industrial hemp;

1	(2)	Act as a resource for licensees on regulatory
2		questions regarding the industrial hemp pilot program;
3		provided that the board shall not provide licensees
4		with legal advice;
5	(3)	Provide licensees with industrial hemp seed, upon
6		licensees' request and at licensees' expense, in a
7		quantity and variety determined at the discretion of
8		the board; and
9	(4)	Catalog data received, in cooperation with the
10		licensee, other program participants, and institutions
11		of higher education in the State, for improved methods
12		and techniques in growing, cultivating, and marketing
13		industrial hemp.
14	§1 <b>4</b> 1	-C Licensing. (a) Each applicant for an industrial
15	hemp lice	nse shall submit a signed, complete, accurate, and
16	legible a	pplication form provided by the board between January 1
17	and April	1 of the year in which the applicant plans to grow
18	industria	l hemp, which shall include the following:
19	(1)	The applicant's name, mailing address, and phone
20		number in Hawaii and, if applicable, electronic mail
21		address;

1	(2)	If the applicant is an individual or partnership, the
2		date of birth of the individual or partners;
3	(3)	If the applicant is any business entity other than an
4		individual, partnership, or institution of higher
5		education, documentation that the entity is authorized
6		to do business in Hawaii;
7	(4)	The cultivated variety that will be sown;
8	(5)	The source and amount of certified seed to be used;
9	(6)	The number of acres to be cultivated for seed, viable
10		grain, industrial products, or any combination
11		thereof;
12	(7)	The global positioning system coordinates in decimal
13		degrees from the central most point of the growing
14		area to be cultivated and a map showing the location
15		of the growing area in terms of its address or legal
16		description;
17	(8)	A statement that the applicant is the owner of the
18		growing area to be used for the cultivation or a
19		statement, signed by the owner of the growing area,
20		indicating that the owner has consented to that use.

1	(9)	The address of the place in Hawaii where the applicant
2		will keep the records, books, electronic data, or
3		other documents that are required by this part;
4	(10)	The name and address of each place where the
5		industrial hemp is to be stored, sold, or provided,
6		indicating for each place the form of the industrial
7		hemp; and
8	(11)	The applicant's acknowledgment and agreement to the
9		following terms and conditions:
10		(A) Any information obtained by the board may be
11		publicly disclosed and provided to law
12		enforcement agencies without further notice to
13		the applicant or licensee;
14		(B) The applicant agrees to allow any inspection and
15		sampling that the board deems necessary;
16		(C) The applicant agrees to pay for any sampling and
17		analysis costs that the board deems necessary;
18		(D) The applicant agrees to submit all required
19		reports by the applicable due dates specified by
20		the board; and

1	(E)	The applicant and any partner, directors, or
2		members have not been convicted of any felony
3		related to the possession, production, sale, or
4		distribution of a controlled substance in any
5		form in this or any other country.

- 6 (b) An application may be received beginning on January 1
  7 of each year and shall be signed by the applicant or, in the
  8 case of a business entity, one of its officers, directors, or
  9 partners, as the case may be, and indicate that all information
  10 and documents submitted in support of the application are
  11 correct and complete to the best of the applicant's knowledge.
- (c) Any incomplete application for a license, or an application received after April 1 of any year, shall be denied.
- (d) In addition to the application form, each applicant
  for a license shall submit a fee set by the chairperson. If the
  fee does not accompany the application, the application for a
  license will be deemed incomplete.
- 18 (e) The annual license fee for production of industrial
  19 hemp shall be \$250 plus \$2 per acre. Moneys collected from
  20 license fees shall be used to cover the costs of implementing,
  21 administering, and enforcing this part.

- 1 (f) All licenses shall be valid for two years from the
- 2 date of issuance, after which the licensee shall renew the
- 3 license and pay the renewal fee, to be established by rules of
- 4 the board.
- 5 (q) Any licensee who wishes to alter the growing areas on
- 6 which the licensee will conduct industrial hemp cultivation
- 7 shall, before altering the area, submit to the board an updated
- 8 address, global positioning system location, and map specifying
- 9 the proposed alteration. If the chairperson receives and
- 10 approves the updated information, the chairperson shall notify
- 11 the licensee in writing that the licensee may cultivate
- 12 industrial hemp on the altered land area.
- 13 (h) A licensee that wishes to change the seed cultivar
- 14 grown shall submit to the chairperson the name of the new,
- 15 approved seed cultivar to be grown. If the chairperson receives
- 16 and approves the change to the seed cultivar, the chairperson
- 17 shall notify the licensee that the licensee may cultivate the
- 18 new, approved seed cultivar.
- 19 (i) If the chairperson determines that the requirements
- 20 for a license pursuant to this part are satisfied, the
- 21 chairperson shall issue a license to the applicant.

- 1 §141-D Reports. (a) At least seven days prior to
- 2 harvest, each industrial hemp licensee shall file a report with
- 3 the board that includes documentation that the licensee has
- 4 entered into a purchase agreement with an industrial hemp
- 5 processor. If the licensee has not entered into such an
- 6 agreement, the licensee shall include a statement of intended
- 7 disposition of its industrial hemp crop.
- 8 (b) Licensees shall report any subsequent changes to the
- 9 purchase agreement or disposition statement to the board within
- 10 ten days of the change.
- 11 (c) Two business days prior to the movement of the
- 12 industrial hemp grain or plant material from the permitted
- 13 location, the licensee shall submit to the board an application
- 14 for movement permit. The application shall include the mode and
- 15 location to which the product is to be transported. An
- 16 inspection of the product may occur prior to movement.
- 17 §141-E Approved seed cultivars. (a) Industrial hemp
- 18 shall be grown only if it is on the list of approved seed
- 19 cultivars. The board may from time to time add or remove any
- 20 seed cultivar from the list if the cultivar is found to be non-
- 21 compliant with this part.

	hemp, including but not limited to any sale or
	disposition of the resulting plants, plant materials,
	or seeds for which the licensee may otherwise receive
	some benefit or consideration;

- (4) Indemnify, hold harmless, and release forever the

  State and its departments, agencies, officers,

  employees, and agents of any kind from all liability

  claims arising out of the licensee's actions involving

  the growth, cultivation, or marketing of industrial

  hemp;
- (5) Warrant that the licensee is not an employee of the

  State and shall assume total and sole responsibility

  for any of the licensee's acts or omissions involving
  the growth or production of industrial hemp or arising

9	concentration allowed by federal law, whichever is greater.
10	(b) During the inspection, the licensee or the licensee's
11	authorized representative shall be present at the growing area.
12	The licensee or authorized representative shall provide the
13	board's inspector with complete and unrestricted access to all
14	industrial hemp plants and seeds whether growing or harvested;
15	all land, buildings, and other structures used for the
16	cultivation and storage of industrial hemp; and all documents
17	and records pertaining to the licensee's industrial hemp
18	business.
19	(c) Sampling of industrial hemp plants shall occur in the

- Quantitative laboratory determination of the delta-9 tetrahydrocannabinol concentration on a dry weight basis shall be performed according to protocols approved by the chairperson;

- 4 amended by designating sections 141-1 to 141-11 as part I,

- 7 amended by adding a new section to part IV to be appropriately
- 8 designated and to read as follows:

#### Report Title:

Industrial Hemp; Agriculture; Pilot Program; Appropriation

#### Description:

Establishes an industrial hemp pilot program to allow the cultivation of industrial hemp and distribution of its seed in Hawaii through limited activities by licensee-agents of the board of agriculture for purposes of agricultural or academic research. Appropriates funds for industrial hemp pilot program administrative costs and program coordinator and inspector positions within the department of agriculture. Repeals on June 30, 2021. (CD1)
