A BILL FOR AN ACT

RELATING TO SELF-STORAGE INSURANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature recognizes that limited lines SECTION 1. 2 licenses are common solutions for insurance in industries such 3 as self-service storage. Specifically, the self-service storage 4 facilities offer customers an affordable insurance option if 5 those customers do not have a homeowners' or renters' insurance policy, which would typically cover the contents within a 6 7 storage unit. Many of the customers of self-storage facilities 8 are not insured under a homeowners' or renters' insurance policy 9 and are unlikely to seek insurance from the traditional 10 insurance market. Moreover, the generally short-term and low-cost nature of the underlying storage unit contract provides 11 12 little economic incentive for insurance agents to pursue self-13 service storage customers on a regular basis, thus making it 14 difficult for people wishing to procure insurance to protect the 15 value of their stored property. Accordingly, authorizing the 16 insurance commissioner to issue limited licenses will provide

- 4 commissioner to issue a limited license for the solicitation or
- 5 sale of insurance to a self-storage facility customer for the

- 8 SECTION 2. Section 431:9A-107.5, Hawaii Revised Statutes,
- 9 is amended by amending subsection (a) to read as follows:

- a common carrier of persons or property who shall act
