A BILL FOR AN ACT

RELATING TO THE SALE OF E-LIQUID.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that according to the SECTION 1. 2 Centers for Disease Control and Prevention, calls to poison 3 control centers across the country related to exposure to nicotine in cigarettes have grown considerably since 2010. 4 Poison experts warn that concentrated nicotine in liquid form is 5 significantly toxic, even in small doses, as poisonings related 6 7 to e-liquid containers can occur when nicotine is inhaled or 8 absorbed through the skin or eyes.

9 The legislature further finds that the packaging and use of 10 electronic smoking devices is potentially hazardous to the 11 health of Hawaii residents, including Hawaii's children, yet 12 many liquids for electronic smoking devices are offered in 13 flavors and scents that are appealing to children. There are 14 currently no packaging requirements for the sale of e-liquid 15 containers. Stringent packaging and labeling requirements for 16 e-liquid containers will protect young children from inadvertent 17 exposure to the contents of electronic smoking device cartridges

and also inform consumers whether an e-liquid product contains 1 nicotine, a highly addictive substance. 2 The purpose of this Act is to establish safe and 3 4 responsible packaging requirements for e-liquid containers to 5 protect Hawaii's children and ensure consumers are better 6 informed regarding the contents of electronic smoking device 7 products. 8 SECTION 2. Chapter 328J, Hawaii Revised Statutes, is 9 amended by adding a new section to be appropriately designated 10 and to read as follows: 11 "§328J- Sale of certain e-liquid containers prohibited. 12 (a) It shall be unlawful for any person or business to sell, 13 offer for sale, or introduce into commerce in the State an 14 e-liquid container unless the e-liquid container constitutes 15 child-resistant packaging. 16 (b) It shall be unlawful for any person or business to 17 sell, offer for sale, or introduce into commerce in the State an 18 e-liquid container for an e-liquid product containing nicotine 19 unless the packaging for the e-liquid product clearly and 20 legibly states:

3	"E-liquid" means a liquid product, whether or not it			
4	contains nicotine, that is intended to be vaporized and inhaled			
5	using an electronic smoking device.			
6	"E-liquid container" means a bottle or other container of			
7	e-liquid. This term does not include a container holding liquid			
8	that is intended for use in an electronic smoking device if the			
9	container is pre-filled and sealed by the manufacturer and is			
10	not intended to be opened by the consumer."			
11	SECTION 4. Chapter 330C, Hawaii Revised Statutes, is			
12	amended by adding a new section to be appropriately designated			
13	and to read as follows:			
14	"§330C- E-liquid packaging standards. It shall be			
15	unlawful for any person or business to sell, offer for sale, or			
16	introduce into commerce in the State an e-liquid container			
17	unless the e-liquid container or e-liquid product is packaged			
18	pursuant to section 328J"			
19	SECTION 5. Section 330C-3, Hawaii Revised Statutes, is

this chapter in order to protect the public
health.

The term "hazardous substance" shall not apply to 3 (D) pesticides subject to the Federal Insecticide, 4 Fungicide, and Rodenticide Act, nor to foods, 5 drugs, and cosmetics subject to the Federal Food, 6 7 Drug, and Cosmetic Act, nor to substances intended for use as fuels when stored in 8 containers and used in the heating, cooking, or 9 refrigeration system of a house, but such term 10 11 shall apply to any article which is not itself an 12 economic poison within the meaning of the Federal Insecticide, Fungicide, and Rodenticide Act but 13 which is a hazardous substance within the meaning 14 15 of subparagraph (A) of this paragraph by reason 16 of bearing or containing such a pesticide. 17 (E) The term "hazardous substance" shall not include any source material, special nuclear material, or 18 19 byproduct material as defined in the Atomic 20 Energy Act of 1954, as amended, and regulations

1		issued pursuant thereto by the Atomic Energy
2		Commission.
3	<u>(F)</u>	E-liquid as defined in section 328J-1; provided
4		that e-liquid containers and e-liquid products
5		shall be packaged pursuant to section 328J"

Report Title:

E-liquid; Electronic Smoking Devices; Packaging Requirements; Prohibitions; Penalties

Description:

Beginning January 1, 2017, prohibits the sale of an e-liquid container for an electronic smoking device unless the container is child-resistant and prohibits the sale of an e-liquid container for an e-liquid product containing nicotine unless the e-liquid product packaging is labeled with warning language. Establishes penalties. Includes e-liquid under the definition of "hazardous substance" as used in the Hawaii Poison Prevention Packaging Act. (SD1)
