A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO THE HAWAII CONSTITUTION TO IMPOSE TERM LIMITS UPON SENATORS AND REPRESENTATIVES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to propose an
- 2 amendment to article III, section 4, of the Constitution of the
- 3 State of Hawaii to limit state senators to three consecutive
- 4 four-year terms and state representatives to six consecutive
- 5 two-year terms.
- 6 SECTION 2. Article III, section 4, of the Constitution of
- 7 the State of Hawaii is amended to read as follows:
- 8 "ELECTION OF MEMBERS; TERM
- 9 Section 4. (a) Each member of the legislature shall be
- 10 elected at an election. If more than one candidate has been
- 11 nominated for election to a seat in the legislature, the member
- 12 occupying that seat shall be elected at a general election. If a
- 13 candidate nominated for a seat at a primary election is
- 14 unopposed for that seat at the general election, the candidate
- 15 shall be deemed elected at the primary election.



1	(b) The term of office of a member of the house of
2	representatives shall be two years [and the], provided that
3	beginning with terms commencing on the day of the general
4	election of 2020, no member shall serve for more than six
5	consecutive two-year terms.
6	(c) The term of office of a member of the senate shall be four
7	years[-], provided that beginning with terms commencing on the
8	day of the general election of 2020, no member shall serve for
9	more than three consecutive terms.
10	(d) For purposes of computing the term limits in this section,
11	the following shall be considered to have served a full term of
12	office:
13	(1) Any member of the senate whose term does not
14	expire at the 2020 general election but who has two
15	years remaining in the current term of office; and
16	(2) Any person appointed or elected to fill a vacancy
17	in the legislature and who serves at least one-half of
18	a term of office.
19	The term of a member of the legislature shall begin on the day
20	of the general election at which elected or if elected at a

- 1 primary election, on the day of the general election immediately
- 2 following the primary election at which elected. For a member of
- 3 the house of representatives the terms shall end on the day of
- 4 the general election immediately following the day the member's
- 5 term commences. For a member of the senate, the term shall end
- 6 on the day of the second general election immediately following
- 7 the day the member's term commences."
- 8 SECTION 3. The question to be printed on the ballot shall
- 9 be as follows:
- 10 "Shall state senators be limited to serving three
- 11 consecutive four-year terms and shall state representatives be
- 12 limited to serving six consecutive two-year terms, beginning
- 13 with terms commencing on the day of the general election of
- **14** 2020?"
- 15 SECTION 4. Constitutional material to be repealed is
- 16 bracketed and stricken. New constitutional material is
- 17 underscored.
