- 8 sidewalks, or any other state or county law relating to
- 9 obstructing or occupying a public place, may petition the court
- 10 where the conviction took place to vacate the conviction. A
- 11 petition to vacate the conviction under this section shall be
- filed within three years from the date the final judgment of
- 13 conviction was entered. The proceeding for the petition shall
- 14 be in compliance with the post-conviction proceedings set forth
- in the Hawaii Rules of Penal Procedure, except where it
- 16 conflicts with the provisions of this section.
- 17 (2) The judgment of conviction for an offense described in
- subsection (1) shall be vacated if the court finds by a



1 preponderance of the evidence that at the time of committing the 2 offense the petitioner was: 3 (a) Homeless; 4 (b) Denied access to a homeless facility, including an 5 emergency shelter or transitional shelter, at least 6 five days prior to committing the offense; or 7 (c) Denied access to services or programs offered by a 8 provider agency for the homeless at least five days 9 prior to committing the offense. 10 (3) As used in this section: "Emergency shelter" shall have the same meaning as in 11 12 section 346-361. 13 "Homeless" shall have the same meaning as in section 346-14 361. 15 "Homeless facility" shall have the same meaning as in 16 section 346-361. 17 "Provider agency" shall have the same meaning as in section 18 346-361. 19 "Public place" means any street, sidewalk, bridge, alley or alleyway, plaza, park, driveway, parking lot or transportation 20

facility, or the doorways and entrance ways to any building

- 1 which fronts on any of the aforesaid places, or a motor vehicle
- 2 in or on any such place.
- 3 "Transitional shelter" shall have the same meaning as in
- 4 section 346-361."
- 5 SECTION 2. This Act does not affect rights and duties that
- 6 matured, penalties that were incurred, and proceedings that were
- 7 begun before its effective date.
- 8 SECTION 3. New statutory material is underscored.
- 9 SECTION 4. This Act shall take effect upon its approval.
