"Homeless facility" shall have the same meaning as in 15 16 section 346-361. 17 "Provider agency" shall have the same meaning as in section 18 346-361. "Public place" means any street, sidewalk, bridge, alley or 19 alleyway, plaza, park, driveway, parking lot or transportation 20 21 facility, or the doorways and entrance ways to any building that

- 1 fronts on any of these places, or a motor vehicle in or on any
- 2 such place.
- 3 "Transitional shelter" shall have the same meaning as in
- 4 section 346-361."
- 5 SECTION 2. This Act does not affect rights and duties that
- 6 matured, penalties that were incurred, and proceedings that were
- 7 begun before its effective date.
