### A BILL FOR AN ACT

RELATING TO CORPORATIONS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 5 (a) All domestic and foreign corporations authorized to

- 7 shareholders an annual report that discloses the corporation's
- 8 independent expenditures and contributions to any election
- 9 candidate, candidate committee, or noncandidate committee. The
- 10 report shall set forth an itemized list of:
- 11 (1) The name and address of the entity or candidate to
- whom the independent expenditure or contribution was
- 13 <u>made;</u>
- 14 (2) The dollar amount of each independent expenditure or
- contribution;
- 16 (3) The election for which each independent expenditure or
- 17 <u>contribution is directed;</u>
