A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Act 99, Session Laws
- 2 of 2013, established the Hawaii agriculture workforce advisory
- 3 board to advise the department of labor and industrial relations
- 4 on, among other things, projects and programs recommended to
- 5 promote the expansion and development of the State's
- 6 agricultural industry.
- 7 The purpose of this Act is to implement the recommendation
- 8 of the Hawaii agriculture workforce advisory board that the
- 9 State should create an agriculture workforce development
- 10 pipeline initiative to conduct training on all islands for
- 11 teachers and school administrators in agricultural self-
- 12 sufficiency.
- 13 SECTION 2. Chapter 371, Hawaii Revised Statutes, is
- 14 amended by adding a new section to be appropriately designated
- 15 and to read as follows:
- 16 "§371- K-12 agriculture workforce development pipeline
- 17 initiative. (a) There shall be created in the department of

- 1 labor and industrial relations a k-12 agriculture workforce
- 2 development pipeline initiative to conduct training sessions for
- 3 teachers and school administrators on the islands of Oahu,
- 4 Hawaii, Maui, Molokai, Lanai, and Kauai, regarding agricultural
- 5 self-sufficiency.
- 6 (b) The k-12 agriculture workforce development pipeline
- 7 initiative shall be headed by a coordinator who shall be
- 8 appointed by the director of labor and industrial relations,
- 9 subject to chapter 76. The coordinator shall develop and
- 10 propose incentives, including scholarships, travel offsets,
- 11 course credits, and stipends. The coordinator may hire, subject
- 12 to chapter 76, necessary staff, including a workforce
- 13 development specialist, to carry out the purposes of this
- 14 section.
- 15 (c) Course material for the training sessions under
- 16 subsection (a) shall be approved by the Hawaii agriculture
- 17 workforce advisory board established pursuant to section 371-19.
- (d) The department of labor and industrial relations shall
- 19 submit annual reports to the legislature on the activities of
- 20 the k-12 agriculture workforce development pipeline initiative."

1	SECTION 3. There is appropriated out of the general
2	revenues of the State of Hawaii the sum of \$ or so much
3	thereof as may be necessary for fiscal year 2016-2017 for the
4	development, operation, and implementation of the K-12
5	agriculture workforce development pipeline initiative, including
6	the hiring of a full-time equivalent (FTE) coordinator and a
7	full-time equivalent (FTE) workforce development specialist.
8	The sum appropriated shall be expended by the department of
9	labor and industrial relations for the purposes of this Act.
10	SECTION 4. New statutory material is underscored.
11	SECTION 5. This Act shall take effect on July 1, 2016.
