### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Act 116, Session
- 2 Laws of Hawaii 2013, is scheduled to sunset on June 30, 2015.
- 3 The legislature further finds that Act 116 mandates the director
- 4 of public safety to maintain a list of independent civil process
- 5 servers in order to shield the State and the department from
- 6 liability arising from the acts of independent civil process
- 7 servers. Act 116 also establishes a working group to make
- 8 recommendations to the legislature regarding the duties,
- 9 qualifications, and regulation of civil process servers and
- 10 other relevant issues.
- 11 The purpose of this Act is to repeal the sunset date of Act
- 12 116, Session Laws of Hawaii 2013, relating to process servers.
- 13 SECTION 2. Act 116, Session Laws of Hawaii 2013, is
- 14 amended by amending section 25 to read as follows:
