RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 88, Hawaii Revised Statutes, is amended 2 by adding to subpart C of part II a new section to be 3 appropriately designated and to read as follows: 4 "§88- Forfeiture of benefits; felony 5 convictions. (a) If a member, former member, or retirant is 6 convicted of a felony and the court finds that, by a 7 preponderance of the evidence, the felony is related to the 8 employment of the member, former member, or retirant by the 9 State or any county, the court may decree a civil penalty, 10 pursuant to section 706-605(8), of forfeiture by the member, former member, or retirant of all or a portion of any: 11 12 (1) Interest; (2) Hypothetical account balance in excess of the amount 13 14 representing any employee contributions made by or on behalf of the member, former member, or retirant; 15 16 (3) Pension; 17 (4) Annuity; or 18 (5) Retirement allowance,

1 to which the member, former member, or retirant may otherwise be 2 entitled under this chapter; provided that upon the death of the 3 member, former member, or retirant, the designated beneficiary 4 of the member, former member, or retirant may receive benefits 5 to which such beneficiary would otherwise be entitled under this 6 chapter; provided further that the designated beneficiary was 7 not also convicted of a felony based on the same set of 8 circumstances as the member, former member, or retirant 9 penalized under this section. 10 (b) Upon receipt of a certified copy of the order 11 decreeing forfeiture, the system shall comply with the order and 12 shall reduce, suspend, or deny payment to the member, former 13 member, retirant, or designated beneficiary, if applicable, as 14 provided in the order until such time as the system receives a 15 certified order to: 16 (1) Increase, resume, or make payments to the member, 17 former member, retirant, or designated beneficiary; or 18 Quash or reverse the decree of forfeiture. 19 The system shall not be required to make inquiry into the 20 propriety of the order decreeing forfeiture or recoup any 21 payments made to the member, former member, retirant, or

or retirant.

MEANS:

Add a new section to subpart C of part II of chapter 88, Hawaii Revised Statutes.

JUSTIFICATION:

This proposal would require the Employees' Retirement System of the State of Hawaii to comply with a court order decreeing a forfeiture of all or a portion of any interest, hypothetical account balance, pension, annuity or retirement allowance otherwise payable a member, former member, or retirant of the system convicted of a felony that the court finds is related to the employment of the member, former member, or retirant by the State or county. proposal does not impair or diminish the accrued retirement benefits of members of Employees' Retirement System protected by article XVI, section 2, of the Hawaii State This proposal applies Constitution. prospectively to felonies committed by public employees after the effective date of the proposal.
