#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§577- Mental health services relating to minors;
- 5 diagnosis, counseling, and related activities. (a)
- 6 Notwithstanding any other law to the contrary, a minor who is
- 7 twelve years of age or older may consent to mental health
- 8 treatment or counseling services provided by a licensed mental
- 9 health professional if, in the opinion of the licensed mental
- 10 health professional, the minor is mature enough to participate
- 11 intelligently in the mental health treatment or counseling
- 12 services.
- 13 (b) The mental health treatment or counseling services of
- 14 a minor authorized by this section shall include involvement of
- 15 the minor's parent or legal guardian, unless the licensed mental
- 16 health professional, after consulting with the minor, determines



- 1 that the involvement would be inappropriate. The licensed
- 2 mental health professional shall state in the client record
- 3 whether and when the treating clinician attempted to contact the
- 4 minor's parent or legal guardian, and whether the attempt to
- 5 contact was successful or unsuccessful, or the reason why, in
- 6 the treating licensed mental health professional's opinion, it
- 7 would be inappropriate to contact the minor's parent or
- 8 guardian.
- 9 (c) A minor may not abrogate consent provided by a parent
- 10 or legal guardian on the minor's behalf. A parent or legal
- 11 quardian may not abrogate consent given by the minor on the
- 12 minor's own behalf.
- 13 (d) If a minor consents to receive mental health treatment
- 14 or counseling services pursuant to this section, the minor shall
- 15 not be liable for payment.
- (e) The minor's parents or legal guardian is not liable
- 17 for payment for mental health treatment or counseling services
- 18 provided pursuant to this section unless the parent or guardian
- 19 participates in the mental health treatment or counseling
- 20 services, and then only for services rendered with the
- 21 participation of the parent or guardian.

5	"Licensed mental health professional" means any of the

8		counselor pursuant to chapter 453D;		
9	(2)	A person designated as a licensed marriage and family		
10		therapist pursuant to chapter 451J;		
11	<u>(3)</u>	A clinical social worker licensed pursuant to chapter		
12		<u>467E;</u>		
13	(4)	A person licensed in the practice of psychology		
14		pursuant to chapter 465; or		
15	<u>(5)</u>	A board certified, or board eligible, psychiatrist."
