# A BILL FOR AN ACT

RELATING TO AQUATIC MITIGATION BANKS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that aquatic mitigation
2	banks restore, create, enhance, or preserve aquatic habitats or
3	resources to recover the ecological functions, services, and
4	values of aquatic resources lost by adverse impacts to other
5	similar aquatic habitats. The federal government and at least
6	twenty-eight states have developed successful mitigation bank
7	guidelines and programs. Mitigation banks would serve as a
8	mechanism to restore or replace aquatic resources and ecological
9	functions of aquatic habitats either prospectively, or after
10	they have been damaged.
11	The purpose of this Act is to authorize the department of
12	land and natural resources to establish and operate aquatic
13	mitigation banks to restore, create, enhance, or preserve
14	aquatic habitats or resources as compensatory mitigation where a
15	person is required to provide compensatory mitigation
16	prospectively and the use of banked mitigation is approved by
17	the agency requiring mitigation, or for past damages to aquatic
18	habitats or resources.

1	SECTION 2. Chapter 187A, Hawaii Revised Statutes, is
2	amended by adding a new part to be appropriately designated and
3	to read as follows:
4	"PART . AQUATIC MITIGATION BANKS
5	§187A- Aquatic mitigation banking. The department is
6	authorized to establish and operate aquatic mitigation banks,
7	the purpose of which shall be to restore, create, enhance, or
8	preserve aquatic habitats or resources as compensatory
9	mitigation where a person is required to provide compensatory
10	mitigation prospectively and the use of banked mitigation is
11	approved by the agency requiring mitigation, or for past damages
12	to aquatic habitats or resources.
13	§187A- Rules. The department may adopt rules pursuant
14	to chapter 91 necessary for the purposes of this part."
15	SECTION 3. This Act shall take effect upon its approval.

PURPOSE:

To authorize the Department to establish and operate aquatic mitigation banks to restore,

create, enhance, or preserve aquatic habitats or resources as compensatory

mitigation.

MEANS:

Add a new part to chapter 187A, Hawaii

Revised Statutes.

JUSTIFICATION:

Aquatic mitigation banks restore, create, enhance, or preserve aquatic habitats or resources to recover the ecological functions, services, and values of aquatic resources lost by adverse impacts to other similar aquatic habitats. The federal government and at least twenty eight states have developed successful mitigation bank guidelines and programs. The benefits of mitigation banks include: (1) increased potential for successful offset of impacts to aquatic habitats and resources and (2) potential protection and preservation of the State's highest value and highest functioning aquatic habitats.

Mitigation banks would serve as a mechanism for the Department to restore or replace aquatic resources and ecological functions of aquatic habitats either prospectively, or after they have been damaged. This bill authorizes the Department to establish and operate aquatic mitigation banks to restore, create, enhance, or preserve aquatic habitats or resources as compensatory mitigation.

Impact on the public: The benefits of aquatic mitigation banks include the potential protection and preservation of the

State's highest value and highest functioning aquatic habitats.

Impact on the department and other agencies: This bill proposes to provide a mechanism for the Department to improve its management responsibilities to protect and conserve

public trust resources.
