A BILL FOR AN ACT

RELATING TO HAWAIIAN LANGUAGE EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that in response to S.R.
- 2 No. 97, S.D. 1, regular session of 2015, the office of the
- 3 president of the University of Hawaii system and the director of
- 4 the Hawaiian language college, in collaboration with a working
- 5 group of various community, government, and higher education
- 6 stakeholders, produced an extensive report on strengthening
- 7 Hawaiian language education in the University of Hawaii system.
- 8 The legislature further finds that the report included
- 9 recommendations relative to the restructuring of the Hawaiian
- 10 language college, specific strategies to enhance and expedite
- 11 Hawaiian language instruction on the different campuses of the
- 12 University of Hawaii system, and recommendations for use of the
- 13 Hawaiian language college as a base from which to carry out
- 14 those strategies.
- 15 The legislature also finds that in order for
- 16 recommendations of the report to be realized, especially those
- 17 that involve the University of Hawaii system beyond the

- 1 restructuring of the Hawaiian language college, there is a need
- 2 for an implementation plan.
- 3 SECTION 2. The president of the University of Hawaii
- 4 system and the director of the Hawaiian language college shall
- 5 produce an implementation plan for the report submitted in
- 6 response to S.R. No. 97, S.D. 1, regular session of 2015, with
- 7 input from a stakeholder group similar to that which provided
- 8 input to the report.
- 9 SECTION 3. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of \$ or so
- 11 much thereof as may be necessary for fiscal year 2016-2017 to
- 12 carry out the implementation plan produced by the president of
- 13 the University of Hawaii system and the director of the Hawaiian
- 14 language college at the University of Hawaii as directed by this
- 15 Act, as well as any pilot programs or pilot strategies that the
- 16 office of the president of the University of Hawaii system and
- 17 the director of the Hawaiian language college at the University
- 18 of Hawaii jointly decide to initiate.
- 19 The sum appropriated shall be expended by the University of
- 20 Hawaii for the purposes of this Act.
