# A BILL FOR AN ACT

RELATING TO THE STATE ETHICS COMMISSION.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I		
2	SECTION 1. Act 151, Session Laws of Hawaii 2015,		
3	appropriated \$130,000 in general funds for fiscal year 2015-2016		
4	to the state ethics commission for the design and development		
5	an electronic filing system. The executive director of the		
6	state ethics commission, however, has indicated that the total		
7	amount of the appropriation will not be expended due to the		
8	implementation of an alternative, less costly design and		
9	development approach.		
10	The purpose of this part is to reduce the appropriation in		
11	Act 151, Session Laws of Hawaii 2015, from \$130,000 to \$		
12	to design and develop the electronic filing system.		
13	SECTION 2. Act 151, Session Laws of Hawaii 2015, is		
14	amended by amending section 2 to read as follows:		
15	"SECTION 2. There is appropriated out of the general		
16	revenues of the State of Hawaii the sum of [\$130,000] \$		
17	or so much thereof as may be necessary for fiscal year 2015-2016

- 2 electronically file required statements and reports with the
- 3 state ethics commission.
- 4 The sum appropriated shall be expended by the state ethics
- 5 commission for the purposes of this Act."
- 6 PART II
- 7 SECTION 3. The legislature finds that the funds not
- 8 necessary to cover the costs for the design and development of
- 9 an electronic filing system should be reappropriated for other
- 10 costs expected to be incurred by the state ethics commission.
- 11 The purpose of this part is to:
- (1) Establish a task force to review and make
- recommendations regarding the lobbyist laws under
- 14 chapter 97, Hawaii Revised Statutes; and
- 15 (2) Appropriate funds to the state ethics commission to
- 16 establish a task force to review state lobbyist laws.
- 17 SECTION 4. (a) There is established a lobbyist law task
- 18 force within the state ethics commission for administrative
- 19 purposes only. The purposes of the task force shall be to
- 20 examine the State's lobbyist laws and make recommendations to
- 21 the legislature to amend these laws, if deemed necessary.

2	(1)	Review and analyze for effectiveness, efficiency, and
3		enforceability the lobbyist laws under chapter 97,
4		Hawaii Revised Statutes, and other state laws that
5	·	affect the lobbyist laws;
6	(2)	Explore and examine the lobbyist laws of other
7		jurisdictions and determine whether the statutory
8		models of other jurisdictions may be appropriate for
9		the State's lobbyist laws;
10	(3)	In addition to the review under paragraph (1), conduct
11		a distinct review and examination of the State's
12		lobbyist laws, not limited to chapter 97, Hawaii
13		Revised Statutes, as they relate to the executive
14		branch;
15	(4)	Engage in discussions with stakeholders who engage in
16		lobbying activities to gain perspective regarding the
17		State's lobbyist laws; and
18	(5)	Address any other issues that the state ethics
19		commission deems necessary to accomplish the purposes
20		of the task force.

- 1 (c) The task force shall comprise members to be selected
- 2 by the state ethics commission who are:
- 3 (1) Registered lobbyists;
- 4 (2) Representatives of organizations involved in lobbying;
- 5 (3) Government accountability groups;
- 6 (4) Community stakeholders; and
- 7 (5) Other members whom the state ethics commission deems
- 8 necessary to accomplish the purposes of the task
- 9 force.
- 10 Members of the task force shall serve without compensation. The
- 11 state ethics commission shall provide the task force with the
- 12 resources and staff support necessary for the accomplishment of
- 13 its duties. The task force shall cease to exist on June 30,
- **14** 2017.
- 15 (d) The task force shall submit a written report of its
- 16 findings and recommendations, including any proposed
- 17 legislation, to the legislature no later than twenty days prior
- 18 to the convening of the regular session of 2017.
- 19 SECTION 5. There is appropriated out of the general
- 20 revenues of the State of Hawaii the sum of \$ or so much
- 21 thereof as may be necessary for fiscal year 2016-2017 for the



- 1 payment of expenses incurred for administering and operating the
- 2 lobbyist law task force established pursuant to this part.
- 3 The sum appropriated shall be expended by the state ethics
- 4 commission for the purposes of this part.
- 5 PART III
- 6 SECTION 6. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 7. This Act shall take effect on July 1, 2030.
