A BILL FOR AN ACT

RELATING TO UNEMPLOYMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to create a
- 2 temporary program providing additional benefits to unemployed
- 3 workers by extending their unemployment insurance benefits. The
- 4 funds for state additional benefits payable under this Act shall
- 5 be withdrawn from the unemployment compensation trust fund
- 6 pursuant to sections 383-121 to 383-123, Hawaii Revised
- 7 Statutes. If necessary, additional moneys may be allocated from
- 8 the state general fund and used for the payment of expenses
- 9 incurred for the administration of state additional benefits.
- 10 SECTION 2. For the purpose of this Act:
- 11 "Benefit year" shall be defined as in section 383-1, Hawaii
- 12 Revised Statutes.
- 13 "Continued claim certification" means an application that
- 14 certifies the completion of a week of total, part-total, or
- 15 partial unemployment to claim benefits for a week of
- 16 unemployment as described in the definition of "continued claim"
- 17 certification" in section 12-5-73, Hawaii Administrative Rules.

- 1 "Initial claim" includes a new claim, an additional claim,
- 2 or a reopened claim as defined in section 12-5-73, Hawaii
- 3 Administrative Rules.
- 4 "Regular benefits" means the unemployment insurance
- 5 benefits paid on an initial claim filed under chapter 383,
- 6 Hawaii Revised Statutes, except as provided for in sections 383-
- 7 168 through 383-176, Hawaii Revised Statutes.
- 8 "State additional benefits" means the unemployment
- 9 compensation benefits payable under this Act.
- 10 "State additional benefits eligibility period" means the
- 11 period beginning on September 4, 2016, and ending on October 28,
- 12 2017. No state additional benefits shall be payable for weeks
- 13 beginning on or after October 29, 2017.
- 14 "Week of unemployment" shall be as defined in section 383-
- 15 1, Hawaii Revised Statutes.
- 16 SECTION 3. An individual shall be eligible to receive a
- 17 payment of state additional benefits with respect to a week of
- 18 unemployment in accordance with this Act; provided that:
- 19 (1) The individual exhausted regular benefits under
- 20 chapter 383, Hawaii Revised Statutes, within the state
- 21 additional benefits eligibility period, or if regular

ī		benefits were not exhausted, the individual's current
2		benefit year expired within the state additional
3		benefits eligibility period;
4	(2)	The individual filed an initial claim and filed
5		continued claim certifications for state additional
6		benefits during the state additional benefits
7		eligibility period;
8	(3)	The week of unemployment falls within the state
9		additional benefits eligibility period;
10	(4)	The individual is not eligible to receive unemployment
11		benefits under federal law or the laws of any other
12		state, or any federal or federal-state extended
13		benefits program during the same weeks within the
14		state additional benefits eligibility period for which
15		state additional benefits are claimed; and
16	(5)	The individual has met all other conditions of
17		eligibility that apply to regular benefits under
18		chapter 383, Hawaii Revised Statutes, except that no
19		individual shall be required to serve a waiting period
20		in the state additional benefits eligibility period.

- 1 SECTION 4. (a) The weekly state additional benefits
- 2 amount payable to an eligible individual for a week of total
- 3 unemployment within the state additional benefits eligibility
- 4 period shall be an amount equal to the weekly benefit amount
- 5 payable in the individual's current or most recently expired
- 6 benefit year within the state additional benefits eligibility
- 7 period.
- 8 (b) The maximum state additional benefits amount payable
- 9 to any eligible individual during the state additional benefits
- 10 eligibility period shall be thirteen times the individual's
- 11 weekly state additional benefits amount.
- 12 (c) No state additional benefits shall be payable for any
- 13 week beginning prior to the state additional benefits
- 14 eligibility period or for any week beginning after the state
- 15 additional benefits eligibility period ends.
- (d) Additional benefits may be used by claimants to
- 17 complete approved training under section 383-29(e), Hawaii
- 18 Revised Statutes.
- 19 SECTION 5. State additional benefits paid to an individual
- 20 shall be charged against the account of any of the individual's
- 21 base period employers in the same manner as regular benefits

- 1 were charged on the individual's current or most recently
- 2 expired benefit year within the state additional benefits
- 3 eligibility period.
- 4 SECTION 6. Except when the result would be inconsistent
- 5 with this Act, the provisions of chapter 383, Hawaii Revised
- 6 Statutes, which apply to claims for, or the payment of, regular
- 7 benefits shall apply to claims for, and the payment of, state
- 8 additional benefits.
- 9 SECTION 7. No provision contained in this Act shall apply
- 10 to the payment of state additional benefits if the provision
- 11 conflicts with federal statutes and jeopardizes the receipt of
- 12 federal administrative funding and certification for the federal
- 13 Unemployment Tax Act employer tax offset credit.
- 14 If any provision in this Act jeopardizes the receipt of
- 15 federal funds, the governor is authorized to revise any
- 16 provision of this Act to the extent required to maximize the
- 17 receipt of federal funds. The governor shall promptly report
- 18 any revision and reasons therefor to the legislature at the next
- 19 legislative session thereafter.
- 20 The provisions contained in this Act shall only apply when
- 21 the balance of the unemployment compensation trust fund does not

- 1 fall below the adequate reserve fund as defined in section 383-
- 2 63, Hawaii Revised Statutes.
- 3 SECTION 8. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so much
- 5 thereof as may be necessary for fiscal year 2016-2017 to carry
- 6 out the purposes of this Act.
- 7 The sum appropriated shall be expended by the department of
- 8 labor and industrial relations for the purposes of this Act.
- 9 SECTION 9. This Act shall take effect upon its approval
- 11 take effect on July 1, 2016.
