A BILL FOR AN ACT

RELATING TO THE ACQUISITION OF MAKAI LANDS OF KAPUA IN SOUTH KONA ON THE ISLAND OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the makai lands of 2 Kapua in south Kona on the island of Hawaii are a scenic wonder 3 with breathtaking shoreline views. The makai lands of Kapua 4 comprise at least six thousand acres in south Kona that are 5 classified as agricultural or conservation land and are 6 privately owned. Kapua is sparsely populated and evokes strong 7 emotions stemming from its rich heritage, culture, and history 8 of native Hawaiian practices.

9 The legislature further finds that the State should seek to 10 acquire the makai lands of Kapua in the interests of preserving 11 the area's pristine condition for future generations while 12 ensuring the preservation of agricultural and conservation lands 13 in the area.

14 The purpose of this Act is to require the department of 15 land and natural resources to engage in negotiations to acquire 16 the makai lands of Kapua.

1 SECTION 2. (a) The department of land and natural 2 resources shall engage in negotiations with the current 3 landowners of the makai lands of Kapua, island of Hawaii, to 4 acquire those lands on behalf of the State. 5 (b) For purposes of this Act: 6 "Acquire" or "acquisition" means to secure an interest in 7 real property in fee simple or otherwise through means of 8 purchase, sale, or exchange of other real property. 9 "Makai lands of Kapua" means those lands makai of highway 10 11 in south Kona, island of Hawaii, more appropriately 11 designated as tax map keys: (3)8-9-006:003; (3)8-9-006:019; 12 (3)8-9-006:028; and (3)8-9-006:035. 13 SECTION 3. Beginning on July 1, 2016, and every three 14 months thereafter, the department of land and natural resources 15 shall report in writing to the legislature on the status of the 16 negotiations to acquire the makai lands of Kapua. The report 17 shall include information regarding the progress of the department of land and natural resources' due diligence and 18 19 negotiations; provided that the report shall not include any 20 information that the department of land and natural resources

deems confidential or detrimental to the State's negotiating
 position.

3 SECTION 4. (a) The department of land and natural 4 resources shall conduct due diligence and attempt to reach an 5 agreement for the acquisition of the makai lands of Kapua by 6 December 31, 2016. If an agreement is reached, the department 7 of land and natural resources shall immediately notify the 8 governor and the legislature and shall submit proposed 9 legislation, including any necessary appropriation, for the 10 purpose of effectuating the acquisition.

11 (b) If the department of land and natural resources has 12 not reached an agreement for the acquisition of the makai lands of Kapua by December 31, 2016, the department of land and 13 14 natural resources may continue to negotiate with the owners of 15 the makai lands of Kapua. In such event, the department of land 16 and natural resources shall submit quarterly progress reports to 17 the legislature until an agreement is reached or negotiations 18 are terminated.

19 SECTION 5. There is appropriated out of the general
20 revenues of the State of Hawaii the sum of \$500,000 or so much
21 thereof as may be necessary for fiscal year 2016-2017 for due

1 diligence on the makai lands of Kapua, to include but not be 2 limited to a determination of the likelihood that unexploded 3 ordnances exist on any of the parcels of land, and for 4 negotiations to acquire the makai lands of Kapua. 5 The sum appropriated shall be expended by the department of 6 land and natural resources for the purposes of this Act. 7 SECTION 6. This Act shall take effect upon its approval; 8 provided that section 5 shall take effect on July 1, 2016.

Report Title: DLNR; Makai Lands of Kapua; Land Acquisition; Real Property; Negotiation; Appropriation

Description:

Requires the Department of Land and Natural Resources to engage in negotiations to acquire the makai lands of Kapua, island of Hawaii. Authorizes the acquisition to be made through the purchase, sale, or exchange of other real property. Requires the Department of Land and Natural Resources to report to the Legislature in writing on the status of the negotiations beginning July 1, 2016, and every three months thereafter. Provides that the Department of Land and Natural Resources shall attempt to reach an agreement for the acquisition by December 31, 2016; provided that if an agreement is not reached by that date negotiations may continue and the Department shall continue to provide quarterly progress reports. Appropriates \$500,000 to the Department of Land and Natural Resources to conduct due diligence on the makai lands of Kapua and for negotiations to acquire those lands. (SB3071 HD1)
