BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 286-47.2, Hawaii Revised Statutes, is

4	registration[-]; use tax; certificate. (a) The owner of every
5	trailer of the current, previous, and subsequent year model
6	bought out-of-state, subsequently brought into the State, and
7	subject to the use tax under chapter 238 shall provide with the
8	application for registration proof of payment of the use tax
9	pursuant to requirements established by the department of
10	taxation. No certificate of registration shall be issued
11	without proof of payment of the use tax.
12	(b) Upon the registration of a trailer, the director of

- (b) Upon the registration of a trailer, the director of finance shall issue a certificate of registration to the owner, dealer, or manufacturer of the trailer. The certificate shall meet the following requirements:
- 16 (1) It shall contain upon the face thereof, the date it
 17 was issued, the license plate number assigned to the
 18 vehicle, the vehicle identification number of the

1		vehicle, the name and address of the registered owner
2		of the vehicle, and such description of the registered
3		vehicle as may be required by the director of finance.
4		If any of the information subsequently proves to be
5		incorrect due to a typographical error, the dealer,
6		manufacturer, or owner of the trailer shall notify the
7		director of finance of the error by a written
8		certificate stating the reasons for and nature of the
9		error and the correction that should be made on the
10		certificate of registration. Upon receipt of such
11		notification by the director of finance, the
12		certificate of registration shall be corrected
13		accordingly so long as the correction does not
14		constitute a change of the vehicle originally
15		registered. A fee shall be paid to the director of
16		finance for each instance of correction of the
17		registration records. The fee charged for each
18		instance of correction of the registration records
19		shall be established by the county's legislative body.
20	(2)	In addition to the requirements provided for in

2		transfer of interest of the registered owner of the

4	(3)	Every owner of a trailer, except for those trailers
- 5		owned by a company or person operating under the
6		jurisdiction of the public utilities commission, shall
7		carry the certificate of registration with the trailer
8		and shall present the certificate at the request of a
9		police officer. This requirement to carry the
10		certificate of registration with the trailer shall not
11		apply when the certificate is removed for the purpose
12		of application for renewal, transfer of registration,
13		or to record a change in the registration.
14	(4)	The director of finance shall not issue a certificate
15		of ownership for a trailer nor record any liens upon
16		or legal ownership to the trailer."
