## A BILL FOR AN ACT

RELATING TO THE HAWAII HEALTH CORPS LOAN REPAYMENT PROGRAM.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that many residents of
- 2 Hawaii are increasingly unable to obtain timely and appropriate
- 3 health care due to shortages of primary health care providers in
- 4 the State. These shortages threaten the health of Hawaii's
- 5 residents and affect state health care costs. These shortages
- 6 have pushed the federal government to designate a number of
- 7 areas in the State, particularly rural areas, as medically
- 8 underserved areas, health professional shortage areas, or as
- 9 having medically underserved populations.
- 10 The legislature further finds that the increasingly high
- 11 cost of health care professional education requires individuals
- 12 to seek out the higher incomes that allow them to repay, their
- 13 student loans. However, these higher incomes are usually in
- 14 specialty care in urban areas, not in the areas of greatest need
- 15 in Hawaii. Since September 1, 2012, a total of sixteen
- 16 physicians and nurse practitioners have received loan repayment
- 17 to work in health professional shortage areas in Hawaii and are

- 1 still serving these communities through a loan repayment program
- 2 started by the John A. Burns school of medicine. The program
- 3 was started with private donations and matching federal funding.
- 4 The purpose of this Act is to fund the Hawaii health corps
- 5 loan repayment program under the John A. Burns school of
- 6 medicine to provide loan repayment for physicians, physician
- 7 assistants, nurse practitioners, psychologists, and social
- 8 workers who agree to work in a federally designated health
- , 9 professional shortage area or an area of Hawaii found to be
- 10 underserved.
- 11 SECTION 2. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$1,000,000 or so much
- 13 thereof as may be necessary for fiscal year 2015-2016 and the
- 14 same sum or so much thereof as may be necessary for fiscal year
- 15 2016-2017 for the implementation and administration of the
- 16 Hawaii health corps loan repayment program.
- 17 The sums appropriated shall be expended by the John A.
- 18 Burns school of medicine of the University of Hawaii for the
- 19 purposes of this Act.

SECTION 3. This Act shall take effect on July 1, 2015.
