A BILL FOR AN ACT

RELATING TO SANDALWOOD.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that sandalwood is an
- 2 aromatic, heavy, and fine-grained timber that has been highly
- 3 valued for centuries. Sandalwood is not only unique from other
- 4 aromatic woods in that it retains its fragrance for decades, but
- 5 it also produces a nut that is a well-known food source for
- 6 Hawaiians. Unfortunately, the slow-growing trees have been
- 7 overharvested and are frequently cut down for the use of the
- 8 timber, without consideration of the valued nuts.
- 9 The legislature further finds that three native sandalwood
- 10 species in Hawaii were exploited for sandalwood trade between
- 11 1790 and 1825, leading to the near extinction of sandalwood in
- 12 Hawaii. While native sandalwood species may still be found in
- 13 Hawaii, they are no longer abundant. Native sandalwood species
- 14 are a rarity in the inhabited lowlands due to the lack of native
- 15 soil, which is vital to their growth, as a result of human
- 16 activities. Despite the rarity of the native sandalwood
- 17 species, sandalwood is still being overharvested and needs to be

- 1 protected. If not protected from overharvesting, the native
- 2 sandalwood species in Hawaii will once again face the strong
- 3 possibility of extinction.
- 4 The purpose of this Act is to maintain a sustainable
- 5 industry and ensure the continued growth of the native
- 6 sandalwood species in Hawaii, including the valued sandalwood
- 7 nut, by prohibiting the sale, export, and possession with intent
- 8 to sell or export of raw or unprocessed timber of native
- 9 sandalwood species.
- 10 SECTION 2. Chapter 183, Hawaii Revised Statutes, is
- 11 amended by adding a new part to be appropriately designated and
- 12 to read as follows:
- 13 "PART , SANDALWOOD
- 14 §183-A Raw or unprocessed timber of native sandalwood
- 15 species; out-of-state sale prohibition; export prohibition. It
- 16 shall be unlawful to sell, offer to sell, export outside the
- 17 State, possess with the intent to sell, or possess with the
- 18 intent to export outside the State any raw or unprocessed
- 19 timber, including whole or partial raw logs, of any native
- 20 sandalwood species. It shall be presumptive evidence of

- 1 possession with intent to sell or export outside the State when
- 2 any evidence may serve to independently establish such intent.
- 3 §183-B Fees. (a) Any person who sells, offers to sell,
- 4 possesses with the intent to sell, possesses with the intent to
- 5 export, or exports raw or unprocessed timber, including whole or
- 6 partial raw logs, of a native sandalwood species shall pay to
- 7 the department a fee equal to per cent of the dollar value
- 8 of the sandalwood that was sold, exported, or intended for sale
- 9 or export.
- 10 (b) All fees collected pursuant to subsection (a) shall be
- 11 deposited in the treasury of the State for use by the department
- 12 for forestry purposes, and all sums so collected and deposited
- 13 are appropriated for those purposes.
- 14 §183-C Criminal penalties. Any person who violates
- 15 section 183-A, upon conviction thereof, is guilty of a
- 16 misdemeanor and shall be fined not more than \$ or
- 17 imprisoned not more than one year, or both. In addition to any
- 18 other penalty imposed under this section, a fine of up to
- 19 \$ shall be levied for each piece of timber illegally
- 20 sold, exported, or possessed with intent to sell or export under
- 21 section 183-A."

- SECTION 3. In codifying the new sections added by section 1
- 2 2 of this Act, the revisor of statutes shall substitute
- appropriate section numbers for the letters used in designating 3
- the new sections in this Act.
- SECTION 4. This Act does not affect rights and duties that 5
- 6 matured, penalties that were incurred, and proceedings that were
- 7 begun before its effective date.
- SECTION 5. This Act shall take effect upon its approval. 8
