BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAH:

8	in the be	d or load-carrying area of the vehicle unless:
9	(1)	There is no seating available in the cab of the
10		vehicle;
11	(2)	The side racks of the vehicle are securely attached
12		and the tailboard or tailgate is securely closed; and
13	. (3)	Every passenger in the bed or load-carrying area of
14		the vehicle is seated on the floor and does not
15		attempt to control unlashed cargo.

(b) This section shall not apply to persons or corporations operating a business or businesses that serve the public, who or which are subject to the jurisdiction,

- 4 (c) No operator of any pickup truck may operate the
- 5 vehicle with any passenger [twelve] under eighteen years of age

- 8 (1) An emergency exists that threatens the life of the
- 9 passenger being transported in the bed or load-
- 10 carrying area of the vehicle; or
- 11 (2) The vehicle is being operated in parades, caravans, or
- 12 exhibitions which are officially authorized or
- otherwise permitted by law.
- 14 (d) Any passenger in the bed or load-carrying area of a
- 15 pickup truck shall be deemed to have assumed the risk of injury
- 16 or death as a result of an accident or injury occurring while
- 17 the vehicle is in operation.
- 18 [(d)] (e) Any person who violates this section shall be
- 19 subject to a fine of \$25 for each violation; provided that any
- 20 person who violates subsection (c) shall be subject to a fine of
- 21 \$50 for each separate violation.

- 1 [(e)] (f) As used in this section, "pickup truck" means a
- 2 light truck that has a cab on the front part of the vehicle
- 3 covering the driver's seat and an open bed behind the cab
- 4 designed primarily to transport property or cargo, with sides
- 5 and a tailgate to retain the contents within the confines of the
- 6 bed, and has a maximum gross vehicle weight rating (GVWR) of
- 7 11,000 pounds or less."
- 8 SECTION 2. This Act does not affect rights and duties that
- 9 matured, penalties that were incurred, and proceedings that were
- 10 begun before its effective date.
- 11 SECTION 3. Statutory material to be repealed is bracketed
- 12 and stricken. New statutory material is underscored.
- 13 SECTION 4. This Act shall take effect upon its approval.

Raises the age of passengers permitted to ride in the bed of a pickup truck under certain conditions from twelve to under eighteen. Deems passengers in the bed of a pickup truck to have assumed the risk of injury or death from an accident or injury occurring while the vehicle is in operation. (SD1)
